## Solari Special Report: How Can We Network Globally with MP Shuaib Al-Muwaizri



**C. Austin Fitts:** Ladies and gentlemen, welcome to *The Solari Report*. This is a *Special Solari Report* because, in the interest of networking lovers of civilization and freedom fighters globally, we want you to be able to pass this far and wide. It's my privilege to welcome from Kuwait City, a member of the Parliament from there, and head of human rights, MP Shuaib. Welcome to *The Solari Report*. You are our first guest from Kuwait, and I'm really honored.

I've been watching your work. It's wonderful to meet you, if only by online mechanisms. Can we start by you giving a little introduction of what 'triggered' you to go into politics and become such a leader in the human rights movement?

**MP Shuaib Al-Muwaizri:** It is a long story, but it is fortunate to represent the people. When you represent the people, it will be a 'heavy' job because you should do for them what they need to have done.

The first thing is protecting their rights. In the meantime, you know that war is not like before. Women, men, and even children have been changed because of the effect of social media. We are not like before. When you are at the university, you see an even bigger change between the students of the past and the students now. In the past, they would use their efforts anytime to show power. Now with just one click of their cell phone, they can do all of the things.

Before we would write and read and follow, but it's not like it was before. Unfortunately, in the meantime, this 'improvement' has cost us because of what is going on.

I would, first of all, like to start by welcoming you, and I would like to inform you that I have many questions for you. I represent the people, and I have been following what you have done. You are a great woman; you are a great hero doing many things to protect the people's rights.

Our target in life is, not just looking out for ourselves; we are part of the humans worldwide. So, for my children and your children and our families, we are responsible for informing them about the truth.

I would like to say that in my region, you are well-known. I would like to let the

people in our region have a brief introduction about yourself, but before that, I will present myself.

I was elected in 2009 as a member of the Kuwaiti parliament. In 2012, I was the Minister of Housing and National Assembly. Then I resigned from the Kuwaiti department because I saw many things which didn't align with my principles. In 2016, I was elected, and in 2020, I was elected again. Now I am the head of the Human Rights Committee in the Kuwaiti parliament.

I am a person who is looking to do my best in not only protecting Kuwaitis. I am protecting Kuwaitis because they fought for me, but my aim and my main responsibility is for every human in the world, not only in my country. In my country and our region, and in the Middle East, and in the United States and in China, and everywhere, those are the people I protect. We are trying to do our best to present the facts to them.

I have just received one small piece of news that the Secretary of United Nations, António Guterres, has asked the international society to put all of their efforts to finish this pandemic. He asked all the people and all the countries to close this sad chapter forever from the history of humanity. So, I hope that this news will encourage us to follow what should be done to protect the rights of the people.

Fitts: I don't know anything about this; this is new to me. What did he ask?

**Al-Muwaizri:** He asked the international society to try to put all of their efforts into finishing COVID-19, and he requested that all the people in all the countries close this file. I hope that this is what we are looking at.

**Fitts:** Although if you look at what I call the 'control grid' that they are trying to put in place, it looks like they are working rapidly across all the different countries to implement it. Of course, that is one of my great concerns.

I have to ask you about your background. As I've watched and tried to study the role you've played in parliament and the role you've played globally in leadership, you appear like the reluctant politician. You look like you are thinking, "I don't want to do this, but somebody has to do this, and I can't

stand this anymore. So, I'm going to jump in and do it."

There is a reluctance about your career driven by your passion to accomplish something, and I find that very intriguing.

**Al-Muwaizri:** In fact, it is not an easy job. We are in the parliament, and we have some opposition. We have some people who try to stop all of our efforts because they don't believe in democracy or they don't believe that others have their own rights.

We have plenty of fights in parliament between fact and fake. It is like a battle without weapons. Our weapons are our mouths, and this thing is not serving me because each battle that I am going into is for my country and the whole world – the human race.

I would be so sad if I felt that somebody was injured or attacked in the United States or attacked in Kuwait or attacked in Afghanistan. All of us are human. The difference in our colors doesn't mean that you are better or that I am better; the best is that we are together.

**Fitts:** I think that the challenging thing about exploring real solutions and global networks to build real solutions is that we are in a situation where no one can be free unless everyone is free. So, this is an all-or-nothing kind of thing. What it means is I feel that people who have been trying to centralize power have done a great job of networking globally, but the people who are interested in democratic process and decentralization have not done the same great work in networking globally. That is part of what you are trying to do. You are trying to help us come together and find the kinds of real solutions we need if we want to be free.

**Al-Muwaizri:** Yes, this is what we are looking for. In the past, it took days or hours to reach others across great distances. Now we can reach each other in seconds. Many people who are related or involved with the other party tell me that we are not in touch or trying to explain human rights, but we have enough strength, and we are trying to encourage them. We encourage them that they should try to defend their rights, and know we are supporting them.

Because of this, I have selected questions from several people – some of them highly educated and some of them in the media, and some of them ordinary citizens. Because of this, we will analyze these questions.

First, I will tell you something about our region. In our region, there is a shadow of what is going on around us. Through that shadow, we can hear what is going on around us and around the world, but somebody in our region is controlled by the people who are trying to control human beings and trying to control the world. This is our main problem.

We should challenge those kinds of people in order to protect the rise of the people. We can start now on some of the people's questions that I have received.

**Fitts:** We share a common enemy; we both reject Mr. Global's plan. Dive into the questions. Why don't you start and lead the way?

**Al-Muwaizri:** We are together, and we have one enemy. We want to open the window for our people in our region so that they can know the truth. When we are trying to show the truth, there are many attacks from others to protect themselves. They don't protect themselves by telling the truth, but by hiding the truth. They express small wisdom, saying, "The best way to defend yourself is by attacking others." This is what our enemy – the enemy of the human race – is doing.

They are not explaining to us or ordinary people the truth; they are trying to hide it. At the same time, they are trying to attack you and me and anyone who is trying to discover the truth.

Many scientists and politicians have been affected by these enemies. There are many countries that have collapsed because of this criminal pandemic.

**Fitts:** Was the COVID-19 as harsh on small business and enterprise in Kuwait as it was in the United States?

**Al-Muwaizri:** Yes, it cost us. I was in the parliament last year when the pandemic started. I don't want to say that it was a 'pandemic' because they

created a pandemic; it was a fake pandemic.

I am also a member of the Kuwait Budget Committee in the parliament, and it cost us 2 billion Kuwait dinar, which is about \$6.5 billion just in the first 18 months.

Fitts: And there are 500 new billionaires. I'm sure that you are thrilled with that, too.

Al-Muwaizri: I think this kind of money goes to them or their partners.

**Fitts:** Do you want me to dive through the questions, or do you want to ask them?

**Al-Muwaizri:** I will ask you the questions to let the listeners and readers know what the questions are. Because this format, I would like to address the worst things that have happened because of these kinds of people – the lives of the people who have died, and the education. They destroyed education, especially for the children. We hope that God will help both of us to tell the truth.

I will start the questions now, and then we will talk about Klaus Schwab and Bill Gates so that people will know who 'they' are. From my side, on the social media and the newspapers, we know that they are a part of that group.

Bill Gates is warning that a new pandemic will happen. How does Bill Gates know about this?

**Fitts:** I used to work on Wall Street, and we call it 'talking your book'. If you look at what Bill Gates is trying to accomplish in this world, I think people believing that there will be another pandemic helps him to achieve what he wants to achieve.

Gates is talking about his book. The question is: Does he believe for environmental reasons or does he believe for political reasons that there will be another pandemic? If you look at the treaty that the WHO is working on, they are trying to create an international treaty that will allow the WHO – which is very much influenced or controlled by Bill Gates – to just declare another global pandemic in a treaty where all the countries have to go along with it.

One of the reasons he may believe there is another pandemic is that he is setting up the mechanism to declare pandemic after pandemic after pandemic. I'm a great believer that he is part of a group of people who are absolutely committed to downloading an operating system in the human body, and they are going to achieve that with constant injections of mysterious ingredients of the kind we have just seen. They can only justify this injection program globally if they have pandemic after pandemic.

We have seen that they have worked tremendously on the technology they need to be able to pretend that there is a pandemic.

**Al-Muwaizri:** Has Bill Gates spoken about the form of the digital implementable tattoo or the microchip? Is there such a thing, and what is Bill Gates' involvement with this?

**Fitts:** There is a form of different technologies that are potential interfaces for brain-machine technology. Microsoft has created patents related to what I would describe as downloading an operating system into your body, whether through a chip or through ingredients in injections that aggregate or the digital tattoo. How far they are in this, I have no idea. What they can do now, I have no idea. But I believe that the group that Gates fronts for is very committed to essentially putting humans on a control grid that includes integrating things into their bodies that will help them do very intimate surveillance and influence and mind control.

I think they are trying to figure out how to do this, and it wouldn't surprise me if one of the goals for the COVID-19 injections were to prototype various forms of this. We know from legitimate researchers that there are secret ingredients – ingredients that were not disclosed. We know that there wasn't informed consent. So the question is: What are the secret ingredients, and what are they expected to do?

I suspect that it relates to prototyping some of these. If that's the case, that's not the first time that we see different countries and different companies working on microchipping people or the digital tattoos. This technology and brain-machine interface is in development and being prototyped. It's real, and we should take it seriously, but there is no clear indication that they have figured out what they want to do and how to do it. I think they are trying to figure that out.

**Al-Muwaizri:** What is the involvement or the relationship between Bill Gates and the World Health Organization?

**Fitts:** My recommendation is, if you haven't read Robert F. Kennedy's book on Fauci and Bill Gates, I would strongly recommend it. He does a very good job of documenting the history, including the financial history.

The Gates and the Gates Foundation have been very involved in basically financing and influencing the World Health Organization. From my vantage point, I would describe the World Health Organization as an organization that is deeply compromised and in the business of compromising sovereign governments. It's part of the process where you create an international treaty and use that treaty to override the sovereign government and its constitutions.

Gates' influence and funding of the World Health Organization has been exceptionally significant.

I do want to say that if you look at how the finances work on the Gates Foundation or Gates' business interests, I think of Gates as a front, not the leader of this operation. You're talking about a significant amount of money, and the investment and financial community doesn't operate individually. In other words, one person like Gates can't completely do this, but they can front for a group of interests.

One of my colleagues calls Bill Gates a 'chew toy'. Do you know what a chew toy is? Do you have chew toys in Kuwait? A chew toy is a toy that you give the dog to chew on. It's a rubber bone that you throw to the dog.

One of my wonderful colleagues says that Bill Gates and Anthony Fauci are the chew toys of COVID-19, and they and Klaus Schwab are going to be thrown away to the crowd.

I think it's important when you look at what Gates is up to, to understand that we are dealing with an investment syndicate and a central banking model. I think the central bankers are at the heart of this. We are looking at a banking and investment community that wants total central control, and Gates is part of what is fronting for them, as is Schwab.

Al-Muwaizri: Where is Fauci now? He seems to have disappeared.

Fitts: That is what I'm told. I haven't really followed Fauci.

I don't know if you have read Kennedy's book yet, but it is fantastic; it is unbelievable research. If you look at the group of people globally that Kennedy has attracted over many years to help him produce something this extraordinary in terms of mastering the complexity, it is quite something.

I thought I knew how evil Fauci was before I read the book. I thought, "I know the 411 (internet slang for information) on Fauci; I don't need to read this book."

I started the book, and I couldn't put it down. I realized that this was much worse than even I had ever dreamed.

If you look at what has been documented now and proved beyond a shadow of a doubt, I'm amazed that Fauci shows up anywhere. If I were Fauci, I would go to the top of the Himalayas and never come back.

Al-Muwaizri: Especially after they announced the documents.

**Fitts:** Here is what astonishes me about the goodness of the human race: These people can still walk down the street safely. If I were them, I would be seriously concerned about my safety.

It is extraordinary that they have been left untouched. We are talking about people who have killed many people.

At some point, the Germans had a phrase called 'desk killers'. We're talking

about desk killing on a huge scale. If I were Anthony Fauci, I would be hiding.

Al-Muwaizri: I think he is under the witness protection program.

Fitts: He could be.

**Al-Muwaizri:** He is part of the crime that has been going on around the world.

**Fitts:** If you look at Fauci from the time he took over his agency, he has allocated \$800 billion (three-quarters of \$1 trillion) into aid. If you look at how he has engineered that, he has made a fortune for the pharmaceutical companies and numerous other private interests that he has handed out billions and billions of dollars to.

I assume that for many, many years, Fauci considered himself untouchable because he was such a money-maker for so many people. This time, I assume that he has done a good job of following orders, but also, there is a point at which your brand has been so sufficiently damaged publicly, you have to go into a witness protection program or get thrown into the chew toy basket.

**Al-Muwaizri:** I received information that this pandemic has gone very well for them. In 2009, Bill Gates talked about this. Thereafter, if you read the management of a concerned department related to the licensing of any medicines, you will see that the FDA and other departments have a good relationship with their manufacturers. Somehow, they were working with the manufacturers, and they moved into the licensing departments and other related departments of licensing medicine.

If you watch or reread what is going on, you will find a strong relationship between licensing the pandemic, creating the pandemic, and the crimes that the people around the world have been engaged in.

**Fitts:** Here is the challenge: If you are Mr. Global and you want to centralize control, the question is: How do you overrun the laws and the Constitution sufficient to give you what you need to get that central control?

In the mid-1990's or 2000's, once he had dealt with the Department of Justice, Gates was part of a group of people who realized the power of healthcare, medicine, and epidemics and pandemics to get control and override the law and the Constitution.

Much of politics is about creating enemies. Some enemies are visible, and some enemies are invisible. The beauty of pandemics is you create an invisible enemy – including one that you can control – and then you have a 'steamroll' that you can use to frighten people and override the Constitutional laws and sovereign laws.

If you go back through the history of them trying to engineer these pandemics, this has been going on for quite some time. That's why understanding the history of Fauci and Gates is very helpful. For many people, they can't fathom that a global pandemic could be falsified and engineered in this way. You have look at the history of how this machinery has been put in place for it to make sense. This is one of the reasons I am so concerned about what the WHO is doing with this new treaty that they are working on.

The WHO has learned plenty in the last two years, and they are working up to taking what they have learned and figuring out how to do it the next time. That may very well be why Bill Gates is saying, "There will be a next time," because they are working on a machinery to make this one much more powerful.

**Al-Muwaizri:** Earlier, the European Council gave the greenlight to start the negotiation on the international transatlantic treaty. They have a strong influence. If you watch their influence, it is over the FDA, the CDC, and the WHO, as well as the European Council. Now, a very big part of the European parliament is fighting against what is going on.

**Fitts:** They are trying to create a control grid. I'm going to grossly oversimply just to make it simple.

If you look at the United States over the last 20-30 years, a great deal of money has been stolen. So, they issue trillions of dollars of debt, and then trillions of dollars disappeared out the 'back door'.

That money represents the money they were going to use for retirement, pensions, and healthcare. So there has been a bank robbery. Rather than saying to people, "Oh, we stole your money," which is not a very political thing to do, they will say, "We have a magic virus, and now we have to cut back. We have to put in a control grid, and that control grid is going to give us the ability to dramatically reduce your economic footprint and your style of life." It's a way of implementing austerity.

So, once you've stolen all the money and you want to keep the money, you need a way of controlling and managing the population. You either need to reduce the population, or you need to put them into a tight control grid. That is exactly what is happening.

I believe all of these are tactics just to create that control grid – whether we do it with vaccine passports or ID wallets or CBDCs. We are talking about getting everybody onto a financial transaction control grid that will give you the ability to sanction the entire global population one person at a time.

We see the U.S. or Europe do economic sanctions towards countries or large or wealthy individuals. They are trying to put in place a system where you can sanction anybody, anywhere, one person at a time using AI and software.

This is a control grid where, if they don't want you travelling more than five miles from your home, your money won't work five miles from your home. Or if they don't want you buying pizza, your money won't buy pizza.

Have you seen the video of the head of the Bank of International Settlements talking about how they can make the rules and enforce them? That is a digital control system.

**Al-Muwaizri:** Earlier, I was in the U.K. for a family relaxation trip. I saw that the small retail shops and the coffee shops don't accept cash money. It wasn't just one, but several shops. If it happened once or twice, that wouldn't be strange, but if it happens in each of the five coffee shops or retail shops, you take notice. I'm not talking about the big brands like Rolex, but the things that cost you one or two or three pounds or five dollars or something. So, when you take your coffee and bring it to the cashier, they say, "Sorry, we do not accept

cash here."

Fitts: You were in the city, right? You were not in the country?

Al-Muwaizri: I was in London.

**Fitts:** My feedback from the United States is that it's going the other way. What has been happening is we have something called 'Cash Friday' where we encourage everybody to use only cash on Fridays. Now another group has 'Cash Everyday'.

People are talking to their hairdresser or their dry cleaner and finding that their businesses can't be profitable because they are spending so much money on credit card and transaction fees. If everybody would use cash, they could get their business back to profitability again.

We are seeing cash in the United States. If you look at the Fed statistics, the outstanding cash balances are growing and growing. There is a push towards cash.

**Al-Muwaizri:** That is good news. What about the digital dollar that Biden has talked about?

**Fitts:** He just came out with a new executive order. They are trying to promote the digital dollar. It's quite simple.

If we all agree to go into a 100% digital transaction system, then they have complete control. I don't care whether it's CBDC (Central Bank Digital Currency) or a credit card. What we have to prevent is 100% digital; that is what we cannot permit.

**Al-Muwaizri:** We are hearing of governments wanting to create digital currency and a one-world bank. What are the risks of having a digital currency and their link to future vaccines? What and how will the link be presented?

**Fitts:** That is an excellent question because a surprising number of people in the United States think, "Things are good because the COVID restrictions are

diminishing." They don't understand that if you can get an all-digital transaction system, that will end currency. It's not a currency; it's a control system.

I believe CBDC is the equivalent of a credit on the 'company store'. What they can do is like the Chinese social credit system, but I think much worse; they can put conditions on your ability to transact.

One example is spatial control: They can define what areas of the world you can travel in, including you not being allowed to leave home. They can stop you from transacting in a whole variety of places for an entire variety of goods. So, if they don't want you buying pizza, you can't buy pizza.

The worst thing, though, is that they can then dictate all sorts of things about your healthcare policy and the intimate aspects of your life. If you want to be able to transact, then they can say, "Well, then you need to get a vaccine every month," or, "You have to have a vaccine every six months."

I try to tell people that the reason you don't want the vaccine passports, or the green pass or the ID wallets, and CBDC going into effect and complying and downloading it onto your phone is that it's the equivalent of a Meta (more comprehensive) mandate. Once they put that system in place, they can mandate whatever they want whenever they want, and you literally won't be able to live unless you've created alternative systems to transact and get food outside the system. That includes them taking your children away, and that is my biggest concern. It's not only that they will mandate injecting mysterious ingredients into your arm, including in a way that makes you sick and kills you, but in fact, they can destroy the family and separate the family.

**Al-Muwaizri:** You know that Klaus Schwab gives order to all departments, and unfortunately, many governments and leaders are following this man. Even in our region, we are followers; we listen and follow. Even if they are going to take us to 'hell', we will follow what they are doing.

Schwab talked about the World Economic Forum. Who is this person?

**Fitts:** I don't take Schwab seriously. First of all, he looks so much like Blofeld from the James Bond movies; he is hard to watch and take seriously.

The World Economic Forum is like many groups around the world where leaders get together, and it gives them a chance to talk and develop ideas and consensus. It supports them on building consensus and creating what I would call a 'field'. That is a very useful function, but I don't see it as a group that has any real power. If anything, I see them as a marketing front for what the central bankers and Mr. Global are trying to do.

This gets back to the idea of chew toys. The central bankers voted in 2019 to do the Going Direct Reset. I see Klaus Schwab and his group as marketing that Going Direct Reset and marketing aspects of it to the youths and a variety of different people around the world. It's sort-of a marketing front and a way to get together.

If you look at the people making the real decisions and driving the train, some of them may go to Davos, but I see Schwab as being very useful as a marketing arm rather than having real power in the Reset.

**Al-Muwaizri:** So, he is doing a job for the others, and some leaders are following Davos (World Economic Forum).

**Fitts:** It's like a puppet show; if you are the people running the real Reset, you don't have time to talk to the public, let alone to market publicly. You need somebody out there doing your marketing.

I see him as being a marketing arm of the central bankers and Mr. Global. Schwab is a person who strikes me as not having his 'feet on the ground'.

**Al-Muwaizri:** He is like a microphone in the hand of the speaker.

Fitts: He's like a cheerleader of the Going Direct Reset; he's a cheerleader.

If you are in a soccer game, and you have two teams and two coaches, and then there are the people who own the two teams. There is plenty of power, and then you have the star players. Then you have the cheerleaders. The cheerleaders get a lot of attention, especially during halftime, but you wouldn't say that they were running the game. **Al-Muwaizri:** He had a statement about genetically editing people. Why don't they hold him accountable for what he has said about genetically editing people? He brought up this statement several times.

**Fitts:** That is a very good question. I don't know. To the extent that I talk to people and attorneys who are bringing legal actions, they are much more inclined to bring legal actions or file notices of liability to the regulatory agents or political leaders who have the power to put up the money and make the decisions.

They are focused on what I would call the 'mechanisms of money and power' more than the cheerleader.

**Al-Muwaizri:** I think that you have seen his most recent video interview. They said they are planning to implement people with high-technology microchips.

**Fitts:** Right. The World Economic Forum has said, "It's 2030, you have no assets, and you're happy." I keep saying what that translates to in English is, "It's 2030, we've stripped you of your assets, and you are mind-controlled or microchipped."

It is astonishing because we see instances of the Secretary of Treasury doing a speech at Davos and being unbelievably complimentary of Klaus Schwab. I was thinking, "You are responsible for the entire U.S. Treasury market and regulatory functions with respect to the U.S. stock market, and you are basically sitting here promoting a man who is talking about ending personal and private property."

I think, to a certain extent, one of the things that is happening – and this happens to me and everybody else – is you are watching something that is so completely incoherent that you are trying to figure out where to attack because the whole thing is so without any kind of logic.

Why would somebody who is in charge of more personal property from a regulatory standpoint than any person in the world encourage somebody who is promoting to destroy private property? Why would you do that?

**Al-Muwaizri:** Can you explain for us what access to the human body this technology gives him?

**Fitts:** I can only speculate about that. Every quarter, we do something called a '*Wrap Up*', and have a whole section called '*Unanswered Questions*'.

If you look at the effort they have been making, there is plenty of speculation about chipping and the tattoos and brain-machine interface, and getting sensors into the body through nanoparticles. I'm not a scientist. I've read a good deal of this material, and what I'm not clear about is what of this technology is just something that is being experimented with, and what technology do they have that really works?

I will say this: There is a group of people in America and Europe called 'the Targeted Individuals' who have been dealing with electronic abuse. They feel that the chipping is happening on an involuntary basis and that it does relate to mind control and the ability to inflict pain.

The way I would say this, based on what I've seen, is I think this type of prototyping is going on right now. The leadership is literally trying to figure out how to make a robot human, and on the other hand, they are trying to take a human and figure out if they can control a human being in the same system that they can use to manage and control robots in one integrated labor force. So, I think there is a real effort to integrate robotics into the labor force and the workforce, and integrate it into the legal system so that there is a continuum from a controlled human to a human-like robot. They are prototyping which works for what function.

Unfortunately, the vision – whether it's Gates or Schwab or any of these people – is one of looking at the human race as if they were livestock as opposed to humans. Their vision is a human race in which an individual human has absolutely no sovereignty and absolutely no rights, and they can enforce that centrally by physically compromising us. They are trying to use technology to do it.

Al-Muwaizri: Klaus Schwab has gone on record saying that has trained young

global leaders such as Merkel, Trudeau, Macron, Bill Gates, Boris Johnson, and many others. He said on video-recorded interviews that he has infiltrated governments. Can you explain this infiltration as a threat to the stability of these countries and their people?

**Fitts:** I just see Schwab as being a 'blowhard' and vastly exaggerating his importance and role in the world.

If you look at any leader, Trudeau is an example: He has a Treasury, he has a central bank, and the Treasury and central bank are coordinating with other G7 central banks and the BIS. If anything, Justin Trudeau is controlled by the bond market and the bankers, not by Klaus Schwab.

To the extent that Klaus Schwab is cheerleading for the bankers and the central bankers, there is an alignment, and they will use Klaus Schwab to do their communication for them. If you think Klaus Schwab has more influence than the bond and derivatives markets on a government leader who is in a debt trap, you're 'smoking dope'.

I think the people who run the financial system are driving what is happening in these countries. One of the reasons they can is that they've been able to put them in a debt trap.

**Al-Muwaizri:** Is there any action in trying to bring them to court or present a legal or criminal case because of what he is saying?

**Fitts:** I don't know. That is an excellent question. Who could get standing in a sovereign nation's court and hold him legally accountable for what he is saying? I don't know. That is a very interesting legal question.

I would think the way to go at it would be RICO Conspiracy (Racketeer Influenced and Corrupt Organizations Act) because he is engaging in a global conspiracy to compromise the laws of different countries. I think the statute in the United States that you would go at this with would be RICO.

I think it's a very interesting legal question as to whether there could be standing or not.

**Al-Muwaizri:** The World Economic Forum speaks of the Fourth Industrial Revolution. What is this?

Fitts: I'm still trying to figure this out!

**Al-Muwaizri:** There are some politics in our region, but I'm in Kuwait, so I'm not afraid or worried about saying anything. They brought up the Industrial Revolution, and it will come back over our heads and our people's heads in the near future.

**Fitts:** I've read the material from the World Economic Forum on this, and I think there is a revolution in material sciences. You get much stronger and lighter technology and can make it much more economical to do things that we never before could have considered. So, there is a new leap forward in what is technologically possible.

It is interesting that without a powerful culture that can handle the technology that we are talking about, we are much more inclined to get a 'mess'. It's a little like giving cavemen laser guns before they've evolved the culture that makes it possible for them to risk manage and handle laser guns. I think it was Einstein who once said that technology acted a bit like an axe in the hands of a serial killer.

I think that the Fourth Industrial Revolution is an effort by a small group of people to use technology to implement very high change at very high speed in a way that gives them total central control of the whole population that ultimately will lead to a mess. So, it's the adaptation of technology by a society that doesn't have the spiritual and cultural grounding in using that technology well yet. We hope we survive the experience so that we can grow up and learn how to use the technology well.

I love a lot of the technology. I think that much of it is 'pretty cool'. I love the idea of things like space elevators.

**Al-Muwaizri:** My understanding is that they are saying to some people in our region, especially in the Middle East and other Gulf countries, "We will give you

and secure you from your people. The best way is to depend on our Industrial Revolution."

This is a big lie. The people of any country are the power of any leader.

**Fitts:** This comes down to what has value. Is it people, or is it tools? You and I agree that it's people, and the tools are there to serve the people, not the opposite.

This gets back to whether or not we can use our technology to build a great civilization. The frustrating thing about building a great civilization is that you have to build it one child at a time, and it takes time. You can't do it fast.

Just because you think you can use technology to replace people doesn't mean that you have the right to do it or that it's a good idea.

I want to tell you a story because I would love for you to know about this. I was in the City of London when I heard this story. I was at an investment conference many years ago, and a wonderful bond manager got up and told this. It's the story of the psychoanalyst, Carl Jung.

A woman came to see Jung, and she was dressed as an aristocrat, clearly very wealthy. She hadn't given Jung her name, and said to him, "I'm not going to tell you my name because I'm only going to come once."

Here was her story: She came from a very wealthy aristocratic family. As a young woman, she had gone to medical school, and did very well. After she graduated, she fell in love with her best friend's husband. She couldn't stand the tension. Given that she was a doctor, she knew how to do it, and murdered her best friend. After her friend died, she married her husband.

Immediately after she got married, she got pregnant, and then everything started to go wrong. She was a very accomplished horsewoman, and the horses bucked and reared. She had these beautiful wolfhounds, and the wolfhounds died. Her husband died shortly after she got pregnant, so she was only married for a very short time. After she gave birth to her daughter, her daughter hated her. As soon as she was old enough to run off, her daughter ran off and left her mother.

She said to Jung that she had been ostracized from society. She told Jung that wherever she went, the birds would stop singing. She said, "The birds knew."

What that story describes to me is a person whose karma has destroyed her life. I would tell you that I think in modern society, we are experiencing karma that is destroying our life. We seem to think that we can solve the problem or fix it with more technology, and I don't think we can.

Our reality is both concrete and visible and invisible, and we are so bankrupting our energetic and spiritual reality that we are at a real tipping point. Whether it's financial capital or fancy technology, we seem to have a planet that is run by hypermaterialists who I think have lost touch with the wisdom that is woven into the fabric of the universe. The question for all of us is: How do we get back to that? It starts with cleaning up our spiritual and energetic reality, which brings us back to human rights and the need to build a culture that is the firm foundation of civilization where, whether it's human rights or sovereign law, it is respected.

We have a group of people running the world who don't respect their own laws and don't obey their own laws. Ultimately, the only place that can get to is dramatic depopulation. If there is no law, there is total chaos.

Increasingly on the world stage, that is what we are seeing. I hate to pinpoint my countrymen, but Lavrov once said of the American political establishment, "They are not agreement capable." We do not keep our agreements.

That has worked well for a period of time, as long as you can ride the reserve currency role. That ride is almost over, which is why there is the scramble for digital transaction control grids.

**Al-Muwaizri:** Our main problem is with some of our leaders in the Middle East. In some countries, it is forbidden to talk about the leaders. Forty or fifty years ago, when they discovered the oil in our territory, the Middle East, the foreign companies came and discovered this oil. Day by day and year by year,

they get wealthy from this oil.

They bought subsidiaries from the owners of oil companies around the world. Some leaders in our Middle East countries started to save their money in the United States and France and Switzerland and the United Kingdom. This came to them as a threat in the present time. They have their wealth outside of their country, so they feel as if they are very weak. The owners of the bank, because of these people like Klaus Schwab and Bill Gates and these kinds of criminals, are threatening them and threatening their wealth.

The same thing happened with the Russian attack on Ukraine. Many businessmen and merchants from Russia, before the war, were highly respected. When the war started, everything collapsed, and they controlled their worth.

This is what will go on in the Middle East countries and in our region if they believe and follow Schwab and Bill Gates. If they think that we are the victims, then we will be the victims. Today, these kinds of leaders are viewed as the victim – and I'm not talking about all leaders; I'm talking about the leaders whom they don't respect and whose countries they don't want to secure and don't respect their people – then tomorrow they will be the victim. The judgment will come to them if they keep silent about what is going on against their people.

**Fitts:** One of the things that I see happening is if you look at the very top group who I call 'Mr. Global', I think they are trying to turn the country leadership and the people against each other. Ultimately, they are looking to the people to take out the country leaders, which will be very convenient for them. That's why I think it's important that we are much better off if we can find more ways to build a win-win between country elites, leadership, and the people.

Part of that is bringing enough money home to build local resiliency in the economy in a way that is win-win. You want to make it attractive for country elites to invest locally and build up the local economy and build up the local education in people. There is a great deal of pressure on them not to do that.

**Al-Muwaizri:** Boris Johnson also had a speech in the United Nations. Boris said that the people belong to the Internet of Things and there will not be

privacy anymore. Everyone's habits will be uploaded into the digital cloud. Tell us about this speech.

**Fitts:** I believe that part of the vision of this digital control grid is every human being is on a blockchain, and 100% of their data is loaded onto that blockchain. Of course, one of the questions is: Is the cloud going to be on a server someplace around the world, or is it going to be on their DNA? They are talking about uploading the data onto a person's DNA and using their body as their cloud.

I think they do envision a zero-privacy world with complete 24/7 invasive access to you and all the data about you.

I often talk about the control grid turning your home into a digital concentration camp. I think that is their vision.

**Al-Muwaizri:** The World Economic Forum has said that you will own nothing, and you will be happy. This statement breaks down human rights, as you are aware. Why has this gone unnoticed? Why hasn't this been challenged in the criminal court of law, and why is Klaus Schwab perceived as a head of state in most countries?

**Fitts:** We discussed this one already. I understand why Schwab would not be the first stop for legal action only because he's kind of a 'floater', and people are more focused on what is happening in their sovereign governments, and protecting their constitutions. I think it's an interesting legal question. If you look at what he is doing, he is basically proposing breaking the law.

It will be an interesting legal question, whether there is a way to get standing and to hold him accountable legally for what he is doing. I think the first place I would look in the U.S. is whether the RICO statutes would apply.

I believe that if you could get Klaus Schwab under deposition, you could absolutely prove that RICO Conspiracies were occurring in the conversations that were happening at Davos. That is a guess.

Al-Muwaizri: I was repeating this question in a different way to allow the

listeners and readers to hear the legal action again. Maybe we will find some lawyers around the world who will look into actions against what is going on. We want to encourage the lawyers in our region to act as international lawyers. Because of this, I phrased this question in another way.

The message of this question is really a message to our region.

**Fitts:** The place where I would be looking for legal action would be against the quantitative easing of the central bankers. That is what is driving the inequality.

I see this as much more of an action against the banks and the central bankers, and I see it as enormous lawlessness in how the money is being created and the Treasurys are being compromised. Maybe it's because I understand financial fraud; I'm much more focused on that angle.

**Al-Muwaizri:** Do you know how the Industrial Revolution is taking place in the Middle East?

**Fitts:** No, I don't. I would love to know. Of course, we all saw the robot get Saudi citizenship. That message was spread around the world.

I really don't know, and I would be very interested to know. I think that if you look at the land in the desert and what can be done in the desert with the Fourth Industrial Revolution, it's quite interesting.

Al-Muwaizri: Maybe it will be covered by the sand of the desert.

What technologies are being carried out around us in the Middle East region? In Kuwait, we need to be aware of what technologies are around us so that we can protect our country, our economy, and the freedom of our people so this scenario doesn't become a threat to us.

**Fitts:** I think this scenario is absolutely a threat. It's partly a cultural issue and partly a legal issue, but it's also partly a financial issue. I would argue that it is very important for each of us not to permit a digital transaction control grid to go into place. It's very important to keep your financial system physical. We like digital; digital is fast and efficient, but we need to keep our cash systems going

and keep them healthy. We need a way of transacting with each other outside of the banking system and trusting each other outside of the banking system.

Keep the basics of life and the financial transaction system enough out of central control. For 'heaven's sakes', whether it's the QR codes, the vaccine passports, the ID wallets, don't adopt them; don't comply.

It's true there are so many more of us than there are of the people trying to do this. We need to understand the central bankers and the banking system want total central control. If we permit it, we lose all of our human rights, all of our laws, all of our freedoms, and all of our protections.

The simple way to do it is to refuse to adopt it. One of the reasons we see a real stepping back of the implementation of the vaccine passports in Europe is that the pushback was so enormous. People were very clear as to where this was going to lead, and they pushed back and pushed back hard. Now we see a reformulation in this push to come with the new treaty in other ways.

It's far from over, but the more individuals say, "No, we will not adopt this because we understand that if we do adopt it, what is going to happen is much, much worse than what is happening now," the better we will be.

**Al-Muwaizri:** If they succeed.

**Fitts:** The interesting thing is that if we simply refuse to adopt it, it cannot go forward. This is a slavery system, and this is a system that will implement digital concentration camps.

The one thing that I would say to the leadership of any sovereign nation is, "This is designed ultimately to turn the people and the local country elites against each other."

If you are a country elite, you have a vested interest in trying to turn it around now and protect the sovereignty of your nation and your people in a way that protects you in the long run from what could happen if you allowed to happen the 'divide and conquer' between the elites and the people. **Al-Muwaizri:** I think it is well-known that our countries will be safe with the people and with the leaders, but not with the Trudeau's and the Bill Gates and Schwab. We are defending our countries, and we will protect them. As we defend our countries, we are also protecting our leaders.

We have a friendly relationship with our leaders, but we are also warning them about what is going on. Our leaders are different than Trudeau and Boris Johnson and Macron. These people have been infiltrated by Schwab and his group.

**Fitts:** When you talk about people who have their money in London or France or these other places, I understand how fragile it can feel to have your money in a variety of places and to be dependent on the system. That is the problem with centralized systems. We all feel so overwhelmed by the need to move to a situation where we are helping each other be globally free. It just seems so big and so overwhelming.

There is a tendency to say, "I'm only one person; what can I do? I'm just going to go along with the system."

In America, we say that we have to go along 'with City Hall'. We say, "I'm just going to go along with City Hall because I'm only one person, and it's too big and it's overwhelming."

The reality is that there are billions of us sitting around saying, "Oh my God! We feel overwhelmed. What can we do?"

What I absolutely believe – and this is the way that I've lived my life since I got 'booted out' of the establishment for doing this – is I am only one person, but I can do what I can do. I think that there are billions of other people who also want to be free.

If you look throughout history, ultimately, tyranny always fails; it never turns out well for the tyrants. So, I'm not saying that freedom is convenient, and I'm not saying that all of us are going to make it if we insist on being free, but I believe it is the only way to live. One of the things that I can tell you, having operated like you in the housing department at the top of my government, is that if you look at where these things are going, I would rather die now trying to be free than to go where they want to go.

You have no idea how dark this is. This is as dark as it gets, and we don't want to go there.

I don't know where the freedom fighters end up, but I would rather be out there in the desert with you fighting for freedom than being stuck in the underground bases with these guys. Trust me! I'll take my chances up here on the ground.

**Al-Muwaizri:** The world is opening up and removing mandates. But Bill Gates is warning of a future pandemic. Is there a link of this future pandemic to the plan for digital currency and vaccines?

**Fitts:** Absolutely. These people have not backed off at all. They have learned a lot in the last two years. They are back in the engine room retooling, and are ready to roll out the control grid.

Take a deep breath and get ready to say, "No," loudly and clearly all around the planet. Let's go!

**Al-Muwaizri:** We can coordinate for this thing because we are all human, and they are trying to put us in a cave or in jail, so we won't stop them. They will absolutely fail. We will continue day by day, and we will be stronger each day.

**Fitts:** The hard part about what I call the 'pro-decentralization team' gathering together is that it's hard for healthy people to fathom where these people want to go. As more and more people do, I think the pushback is going to be unbelievably powerful.

Kennedy always says, "I'll join you on the barricades."

**Al-Muwaizri:** This is a message to all the people in our region: They should act to defend themselves. We are all doing our best to protect them by saying the truth and doing what we can do, but they shouldn't sleep. They should wake up and see what is going against them.

Maybe they will not notice this thing today, but in the future, it will be a disaster for them if they stay at home and keep silent.

**Fitts:** I would say, "Don't be afraid. Don't get frozen in fear." You have to move. Get moving, and don't feel overwhelmed. Just do what you can.

**Al-Muwaizri:** The day of our birthday is the day of the creator, and the death is in the hands of the creator. Nobody can shorten our days or make our death day, which has been created by God. Nobody can stop us until the day of our death.

We think that human rights are about our family, and it is; it is about our children, our families, and other people. The other people have been affected, and one day we will be affected if we keep silent and don't protect them.

I have a few other questions for you. What is the Internet of Bodies? Is it a part of the Great Reset and the Fourth Industrial Revolution?

**Fitts:** I don't know much about it, but I think that the Internet of Bodies is the idea of integrating digital technology into the human body with sensors or tattoos or any of these different technologies and networking us into all things.

If you look at what has happened in the last 30 years in the United States, there is an effort to digitize everything – the atmosphere, homes, equipment, and everything. If you look at how AI works, the competitor with the best AI is the one who gets the most data. Of course, if you digitize everything and provide for a 24/7 data flow, that is the person who has the most data.

We are in a process of trying to integrate digital technology into everybody and everything, including the human body. I think that the vision is one that is very dark, but there is no doubt that this group is going to make an effort to do it.

**Al-Muwaizri:** Before you give a message to our people, I would like to ask you one more question because it is related to what is going on these days. Do you think there is a relationship between the Russian attack on Ukraine and the Russians saying that there are some virus factories in Ukraine? Do you think

that there is a relationship between what is going on with this and the pandemic, and it is part of the plan? What are your comments about the Ukrainian virus factories that have been announced by the Russian government?

**Fitts:** The Russians and the Chinese have said that there were 30 of what the state department appears to have been calling 'biological research labs' instead of 'biological warfare labs'. Victoria Nuland, from the state department, admitted to Senator Rubio in a recent questioning in the Senate that the United States was funding 'biological research labs' in Ukraine.

I would interpret Nuland's comments as admitting that this was true. We can debate whether or not there were 30 or three or how many. I can tell you that if the Russians had financed 30 biological research labs in Mexico, America would have invaded Mexico long ago.

Based on Nuland's testimony, there is no doubt that there is something very real here. It doesn't surprise me because if you look at the history of Fauci and Gates' operation, it's a global operation. I think that in order to preserve the reserve currency, papering the world with hundreds of bio-warfare labs has been one of the tactics.

Based on Nuland's testimony, I am assuming that what the Russians are saying is essentially true.

Al-Muwaizri: Will Congress investigate this?

**Fitts:** I don't know if that is the case. If you are Congress, it's a dangerous topic to open up.

This is a very interesting situation because if you watch the Nuland testimony, Pandora's Box has been opened. The Russians were backed up by very strong statements from the Chinese who were asking for the ability to send in weapon verification and weapon inspectors.

I've tried very hard to get good documentation on what the bio-warfare and research labs around the world are – who is funding them and who controls them. I will say this: One of the problems that we face globally is that we have

very powerful technology, and when a society goes into implosion, it's dangerous.

When a country such as Ukraine diminishes in the quality of the governance and the health of the economy to the point it has, having facilities like that in a society that is imploding is exceptionally dangerous. That is the problem with much of this technology. If we are going to have advanced technology, then we have to have an advanced culture. We can't promote imploding societies around nuclear plants and very sophisticated technology. It's very scary.

I would say that there is something here, but we are never going to get to the bottom of it without international investigation. I don't think the U.S. Congress can do it.

**Al-Muwaizri:** The members of Congress are representing the American cities, and the American cities are then paying taxes. So, the government of the United States is using the money of its citizens for a bad thing if this is the truth. I'm talking about the labs in Ukraine.

**Fitts:** One of the critical issues in the United States is that the U.S. government – in terms of the financial management laws – has failed to obey those laws for many, many years. A time is coming where the citizens have to deal with the fact that they are paying money into an organization that is not following the laws related to financial management.

I would hope that issue would come to a 'head' in the next year or two. This gets back to the question of sovereignty and lawfulness. If we all pay taxes into a government that is not obeying the law, and is subject to international treaties that are not obeying the law and are not obeying human rights, then what do we do and how do we do it?

I would love to see more people follow up on Nuland's testimony because I think that Nuland has opened Pandora's Box.

**Al-Muwaizri:** That is a genuine crisis using the citizen's money for a bad thing and breaking the law of human rights around the world. The United States is one of the main countries defending human rights. By talking to all countries

about 'protecting the human rights', they are saying one thing and doing another thing.

**Fitts:** I don't understand what has been happening in Ukraine other than watching Nuland's testimony and reading some commentaries on it. The one thing that I will say goes back to Kennedy's book. If you don't have a copy of his new book, I will be happy to send you a copy – if you would like one. I have a stack of them.

In the United States, we have been subject to a process called 'the great poisoning' most of the time that Fauci went into his current position. Our population has deteriorated dramatically in terms of health and IQ. Fifty-four percent of the children have a chronic disease, and IQs are falling steadily. It's very, very bad.

If you look at the government policies that have implemented this, we are being poisoned. COVID-19 and the injections from COVID-19 are only part of something that has been going on longer and is much bigger and includes the digitization of everything. That is part of what is doing the poisoning.

I think that it's time to look at the contribution that this poisoning is making to human health and human IQ and ask the question, "What in the world is going on, and how do we stop it?"

As 'cheerleaders' in good standing, I think that Gates and Schwab and some of the other people who have been promoting this poisoning need to be held accountable. So, I commend your efforts for trying.

Al-Muwaizri: Only those who have been infiltrated by Schwab and his group.

**Fitts:** It's interesting because I've watched a terrible deterioration in the leadership of America respecting the people, and the people respecting the leadership. One of the reasons the leadership so disrespects the people is that the people behave in ways that people behave when they are being poisoned. If we weren't poisoning them, they might behave much better.

There is a cycle of disrespect, and it is not unrelated to what happens to your IQ

and your energy and your health when you are poisoned.

**Al-Muwaizri:** Finally, can you give a message to our people about the dangers that come with digital money and what countries should do to protect themselves?

**Fitts:** The danger of digital money is that you can be centrally controlled. I think that digital money can be a fantastic and wonderful tool. I love technology, and I also love money. So, digital technology can be a real blessing where you have a government system that is for the people and for human rights, but I think that it is very important to not let digital money either become a trap for economic sanctions or central control.

I would do everything I could to make sure that whether it's your food or your energy, or whether it's the basic household goods that you need, and a transaction economy, that you have serious alternatives in the physical world that cannot be controlled by any digital system, including digital money.

It's not an either/or thing; there are many, many advantages of digital money, including global transaction at low cost. But never let your system become totally digital because then it won't be money currency; it will be control and slavery, particularly if it is controlled from outside of your sovereign nation.

We want a system that supports sovereign individuals and sovereign nations. An all-digital money system isn't that.

If you don't believe me, I want everybody in Kuwait to go to <u>http://Solari.com</u>. Click on the link for '*Cash Friday*', and you will pick up a 56-second video of the head of the Bank of International Settlements in Basel, Switzerland explaining to you why he and the central bankers will have total central control of all of your money if they have a digital currency. This is done in 56 seconds. It's fabulous.

Also, on my website, if you click on '*Cash Friday*', there is an explanation of why we encourage everybody to use cash on Friday. At the top is a video of Carstens, the head of the Bank of International Settlements in Basel, Switzerland. He explains how, after they have digital currency and CBDC, they

can make the rules, and can enforce the rules. It's chilling, but it's a beautiful example of a central banker – God love him – being honest, which is a very special and rare moment.

**Al-Muwaizri:** We know who is really behind the digital currency and who the founder is. Our people should know about this because it is a dangerous thing.

**Fitts:** If you could get everyone in Kuwait to watch that 56-second video, you will understand why you don't want an all-digital transaction system. I don't care if it's time IOUs, barters, cash or silver, or cigarettes. When the wall came down in Russia, the big one was vodka; vodka was better than gold.

There are many different currency systems throughout history, but you always want resilient and redundant and physical options. Keep it grounded. Take your shoes off, put them in the soil, and keep your money grounded.

**Al-Muwaizri:** It is nice to hear from you on this topic, and I thank you very much. This meeting was a wonderful meeting with a wonderful lady. You are wonderful, and I highly appreciate your efforts to protect human rights and to clarify the truth to the people.

These types of meetings will wake up many people – not only in Kuwait, but all around the world. It will be in the media as soon as possible.

You are great, and excuse me if I had many questions about this crime. At the end of this discussion, I think I received an abundance of beneficial information, and I will explain it to our people. We will advise them and recommend, not just follow this discussion, but all of our reports related to what is going on in the world.

**Fitts:** I really appreciate the opportunity to do this. Someday I hope that when all this craziness is behind us, I can go to Kuwait and meet you in person.

**Al-Muwaizri:** You are welcome. This is an open invitation. Come visit any time. I will receive you from airport to airport.
