INTRODUCTION

The goal of this Family Financial Disclosure Form is to ensure that an adverse event or death of one family member does not translate into long-lived or permanent financial destruction for the entire family.

This form was created to assist families to communicate regarding and to prepare for the family-wide financial impact of adverse events, if any, resulting from a Covid-19 injection. Reported adverse events following Covid-19 injections include: death, anaphylaxis, blood clots and related complications, leaky blood vessels and related complications, heart problems (including myocarditis, pericarditis, and other cardiac issues), neurological disorders, autoimmune disorders, cancer, other chronic and inflammatory conditions, blindness and deafness, infertility, fetal damage, miscarriage and stillbirth, and Covid-19.

Traditionally, informed consent forms for vaccination do not provide disclosure or statistics related to financial costs of possible injury, disability, or death, nor do they discuss the impact on family time, resources, health, and wealth—impacts that may include reduced career potential, divorce, or effects on the education and future plans of other family members.

Consequently, it is essential that prior to receiving a Covid-19 injection, parents and family members with financial responsibility for children and spouses not only do thorough due diligence—providing adequate disclosures to their families regarding the potential costs to family members of adverse events or death—but also take steps to protect themselves and family members from the material adverse financial consequences of an adverse event or death.

Authorized Covid-19 Injections

National regulatory agencies granted emergency authorizations for Covid-19 injections after abbreviated clinical trials and without long-term safety testing. In the U.S., this process resulted in three Covid-19 injections granted "emergency use authorization" (EUA) by the Food and Drug Administration (FDA): the mRNA injections developed by Pfizer with German partner BioNTech (now authorized for ages six months and up) and by biotechnology firm Moderna in partnership with the National Institute of Allergy and Infectious Diseases (NIAID) (also ages six months and up); and the adenovirus-vectored injection made by Janssen, a Johnson & Johnson (J&J) subsidiary (18 years and up). On May 5, 2022, FDA limited the authorized use of the J&J injection to "certain individuals," citing its updated analysis of the risk of life-threatening blood clots (thrombocytopenia); earlier FDA warnings linked the J&J shot to an increased risk of Guillain-Barré syndrome, a condition involving peripheral nerve damage. On June 17, 2022, FDA granted EUA status to both the Pfizer and Moderna injections for use in children all the way down to six months of age, despite children's almost nonexistent risk of illness

In January 2022, a U.S. District Judge ordered the FDA to release, on an expedited basis, hundreds of thousands of pages of Pfizer documents in its possession. Dr. Naomi Wolf,

CEO of the *Daily Clout*, has organized highly trained teams of volunteer experts to review the documents, which are revealing numerous risks and harms not disclosed to the public, including over 1200 deaths in the first three months alone as well as serious risks to unborn babies.

Importantly, though FDA issued formal approval for the Pfizer injection under the brand name "Comirnaty" on August 23, 2021 (for ages 16 and up) and formally approved the Moderna injection under the brand name "Spikevax" on January 31, 2022 (for ages 18 and up), there is no indication that these versions—what some have termed "ghost vaccines"—are actually available in the United States; this means that Americans continue to receive EUA injections, not the licensed versions.⁶

This distinction between EUA and licensed injections has important legal ramifications because, under the Public Readiness and Emergency Preparedness (PREP) Act enacted in the U.S. in 2005, EUA injections are classified as "medical countermeasures" that are immune "from legal liability for all claims for loss" relating to the injections' administration or use. The PREP Act defines "losses" as death; physical, mental, or emotional injury, illness or disability; and "loss of or damage to property, including business interruption loss." Although injured individuals may apply for compensation from the Countermeasures Injury Compensation Program (CICP) within a year of injury, the program—deemed "horrible" by many—has not paid out a single Covid vaccine injury claim; it covers neither legal fees nor pain and suffering, and has a high burden of proof.8 Fully licensed vaccines, when recommended by the Centers for Disease Control and Prevention (CDC) for children or pregnant women, are also immune from liability under the 1986 National Childhood Vaccine Injury Act. Under that legislation, the vaccine-injured can seek compensation from the National Vaccine Injury Compensation Program (NVICP), but that program, too, is cumbersome and historically has only compensated one-third of petitioners. Moreover, even for successful claims, the monetary amount often falls short of the financial devastation created. In theory, the manufacturers of licensed vaccines not on the childhood or pregnancy schedules can be sued—which may be why Comirnaty and Spikevax seem to be available in name only.

Outside the U.S., experimental Covid-19 injections are currently administered under "conditional marketing authorization" (European Union [EU]), "provisional approval" (Australia and New Zealand), or similar emergency provisions in other countries. Initially, many OECD countries authorized and used the Oxford/AstraZeneca injection ("Vaxzevria") developed in the UK, which, like J&J's shot, uses an adenovirus vector, and in May 2022, the European Medicines Agency (EMA) endorsed use of the AstraZeneca injection as a booster. However, following early concerns about blood clots that paused or halted the injection's use in a number of European countries, AstraZeneca's market share steadily declined, with the Pfizer and Moderna injections dominating the market in most high-income nations. The EU is now dumping millions of doses of AstraZeneca's "unpopular" product in low-income countries.

The "Nuvaxovid" injection developed by American biotech firm Novavax received its first EUA from Indonesia in November 2021, with the EU, the UK, Australia, Canada, India, and

other Asian countries subsequently following suit.¹⁴ In June 2022, FDA advisors recommended that the Novavax injection be granted EUA status for use in the United States.¹⁵ FDA has not yet decided whether to authorize it.

As of May 2022, a total of 11 Covid injections had been granted emergency use listing by the World Health Organization (WHO).¹⁶

Covid-19 Injections: Gene Therapy

Though marketed as "vaccines," mRNA and adenovirus-vectored Covid-19 injections are experimental gene therapy, sharing the end goal of getting genetic instructions into a person's cells and "tricking" the cells into making the coronavirus spike protein. This is readily apparent in the language used by the injections' developers.

For example, the never-before-authorized mRNA approach is described as a means of "programming a person's cells"¹⁷ or (using Moderna's terminology) deploying new "software."¹⁸ The Pfizer and Moderna Covid injections use lipid nanoparticles (LNPs) as an in-built "gene delivery" or "carrier" system that transports synthetic mRNA into the cell's cytoplasm; the LNPs not only shield the mRNA and promote cellular uptake, ¹⁹ but also function as adjuvants, "revving up" the immune system. A unique and worrisome feature of these injections is the prospect of the mRNA-LNPs crossing the blood-brain barrier, ¹⁷ which can damage the brain²¹ and result in a "nightmare scenario."²² According to the expert group Doctors for Covid Ethics, the mRNA technology is so inherently dangerous that the Covid injections "should never even have been introduced."¹⁹

The J&J and AstraZeneca injections use genetically modified common cold viruses as a Trojan horse to shuttle spike protein DNA (genetic instructions) into the cells. As Doctors for Covid Ethics reminds the public, "introducing DNA into human cells. . . constitutes gene therapy," raising the possibility of "stable, irreversible incorporation into the human genome." Before Covid-19, adenovirus-vectored injections already had a "checkered past" as a "failed gene therapy." In late 2019, FDA nevertheless approved an adenovirus-vectored Ebola vaccine, and the technology has also been used in experimental Zika and HIV vaccines. The Janssen and AstraZeneca Covid-19 jabs are the first such injections to be authorized (on an emergency basis) for general population use.

Biodistribution studies indicate that all of the Covid injections contain components that can travel from the injection site and accumulate in vital organs such as the liver, adrenal glands, spleen, and ovaries. Doctors for Covid Ethics also hypothesize bioaccumulation in the placenta and lactating mammary glands, posing risks to fertility and to breastfed newborns. In June 2022, Dr. Wolf detailed alarming Pfizer data on pregnancy and baby harms not disclosed by either Pfizer or FDA. This would not be the first time that vaccines have threatened women's fertility, as explained in detail in the 2022 documentary, *Infertility: A Diabolical Agenda*.

Additional Covid-19 Injection Risks

PEG and Polysorbate 8o: The LNPs in mRNA injections are coated with polyethylene glycol (PEG), a controversial polymer—synthetic and nondegradable—associated with adverse immune responses.³⁰ Moderna acknowledged that the LNPs "could lead to significant adverse events,"³¹ and, early on, FDA identified PEG as the likely culprit responsible for hypersensitivity reactions, including anaphylaxis.³² CDC warns individuals with known PEG allergies not to get mRNA injections, telling them to get the J&J injection without mentioning that many people are allergic to PEG without knowing it. The J&J and AstraZeneca injections contain a substance structurally similar to PEG called polysorbate 8o that can provoke the same type of allergic reaction (but CDC tells individuals allergic to polysorbates to get mRNA injections containing PEG!).³³

Contaminants: In addition to containing unknown (or redacted) ingredients, nanoparticles, and proteins derived from fetal cell lines, the Covid injections have been found to contain a variety of contaminants,³⁴ including metallic particles.³⁵ In September 2021, Japan halted the distribution of 1.6 million doses of Moderna vaccine after finding stainless steel particles,³⁶ and more recently, almost three-quarters of a million Moderna batches were recalled in Europe.³⁷

Adjuvants: The Novavax injection features a technology that marshals moth cells to make "lots of spike proteins"; the "premade" spike proteins then get injected, accompanied by a powerful nanoparticle-based adjuvant (reliant on detergent-like substances called saponins) that is said to generate "a more potent immune response." Researchers have documented a number of "undesirable" side effects associated with this type of adjuvant, including the rupturing of red blood cells (hemolysis); in understated fashion, they have noted the need to "balance. . . potency and adverse reactions." ³⁹

Covid-19 Injection Mandates

With the rollout of experimental Covid injections, national and local governments all over the world, along with a wide variety of public and private sector organizations, began putting unethical⁴⁰ vaccine mandates in place—mandates that violate fundamental human rights⁴¹—to coerce the public into accepting the injections and subsequent "boosters." The compulsory measures imposed by schools and universities,⁴² critical industries such as aviation and health care,⁴³ and countries seeking nationwide mandates⁴⁴ generated fierce opposition, including in the courtroom.

Legal and other forms of pushback have successfully overturned mandates in a variety of jurisdictions, with courts and legislators in the U.S., Europe, India, and elsewhere agreeing that such mandates represent constitutional, religious, or medical overreach. In the United States, for example, the Occupational Safety and Health Administration (OSHA) had to withdraw a rule mandating the injections for large employers in January 2022 after the Supreme Court delivered a mixed decision that blocked the OSHA rule⁴⁵ while allowing mandates for health workers.⁴⁶ U.S. airlines, along with the Federal Aviation Administration and U.S. Department of Transportation, are also facing widespread lawsuits.⁴⁷ In early

May, 2022, India's Supreme Court issued a milestone ruling asserting that the Indian constitution "gives everyone the right to refuse vaccination." In European countries such as Germany and Austria, members of parliament have rejected or suspended mandates.

Adverse Events

Since the Covid injections' debut, millions around the world have reported serious adverse reactions—far outstripping recorded adverse reactions to other vaccines⁵¹—and many countries are witnessing a sharp rise in all-cause mortality.⁵²

The ranks of those injured or killed by Covid injections include tens of thousands of previously healthy children in the U.S. and Europe alone, ^{27,53} whereas the Covid survival rate for children is 99.997%. A comprehensive risk-benefit analysis of the use of the mRNA Covid injections in children and adolescents conducted by Doctors for Covid Ethics warns of "catastrophically bad" safety profiles, citing the potential for heart problems, genotoxicity (damage to human genetic material), reproductive toxicity, and autoimmunity, among other possible harms. Parents need to understand the full range of risks, including financial, before allowing a child to receive a Covid injection. ⁵⁴

Adverse events can occur in the short term—or several or more years after vaccination. The alarming uptick in morbidity and mortality following Covid injections already includes increased cancers,⁵⁵ heart problems,⁵⁶ and neurodegenerative diseases,⁵⁷ as well as reproductive problems such as miscarriage, stillbirth, early infant death, female infertility, and ovarian dysfunction.⁵⁸

Nowhere has the devastation caused by Covid injections in young people and younger adults been more apparent than in the world of sports. As professional athletes were pressured to receive the injections, video footage surfaced from all over the world showing countless young and healthy athletes dropping to the ground with heart problems and other sometimes fatal reactions. In a filmed interview, legendary British footballer Matt Le Tissier discussed the explosion of adverse events among athletes, explaining that he had "never seen anything like it" in his years as a football star and sports commentator. ⁵⁹

In December 2021, Professor Mark Skidmore of Michigan State University (with dual appointments in Agricultural, Food, and Resource Economics and Economics) conducted a nationwide survey to estimate the number of fatalities associated with the Covid injections. ⁶⁰ Dr. Skidmore administered the online "Covid-19 Health Experiences Survey" to a representative sample of 3,000 U.S. residents balanced (to the extent possible) on age, gender, and income. The survey collected information about respondents' direct experiences with Covid-19 illness and injections, as well as related experiences within respondents' social circles.

About half of the respondents had received Covid shots (with more than one in six experiencing health issues post-injection), and one in four reported knowing others who had significant post-injection health issues. Respondents described deaths as well as non-fatal but severe adverse events such as heart problems, blood clots, strokes, and paralysis. Extrapolating from his results, Dr. Skidmore's conservative estimate is that between

264,000 and 308,000 people may have died following Covid-19 injections in the U.S., and 1.1 million may have experienced life-threatening or life-shortening injuries. The survey report includes two appendices with 30 pages of vivid and sobering descriptions of adverse events experienced by respondents or people they knew.

Adverse Event Reporting Databases

The following is a selected list of national databases that make adverse event reports available to the public. The numbers reported to these databases are known to vastly undercount vaccine injuries because the "passive" reporting systems rely on the willingness and ability of injured individuals and health care professionals to submit reports.

Vaccine Adverse Event Reporting System (VAERS), Department of Health and Human Services (U.S.)

VAERS is a voluntary reporting system co-administered by the CDC and FDA.⁶¹ Dr. Sherri Tenpenny estimates that VAERS data represent approximately 10% of actual adverse events. A Harvard study commissioned in 2010 by the federal government produced an even lower estimate, concluding that less than 1% of adverse events get reported.⁶² In June 2021, independent analysts estimated that VAERS was about nine weeks behind in publishing adverse events reported following Covid-19 injections, and by August, they suggested "the strong possibility" of "throttling, backlogging, or downright suppression of the death data being reported out of VAERS.⁶³

VAERS reports are accessible through the CDC Wonder search engine or through the more user-friendly MedAlerts search engine maintained by the National Vaccine Information Center (NVIC). MedAlerts also offers more powerful search capabilities and more extensive reporting.

EudraVigilance (27 European countries), European Medicines Agency

The European Medicines Agency maintains a database of suspected adverse drug reactions accessible to the general public, called EudraVigilance, which compiles adverse event reports for each of the five Covid injections currently available in the EU.⁶⁴ The database includes the number of case reports as well as the number of total injuries (an individual "case" may experience multiple injuries).
