The Republican Study Committee, a conservative body of House lawmakers, this year proposed a budget blueprint that would balance the government books as soon as 2023. “I have been surprised by the lack of concern among Republican members of Congress of both houses about the impact of the proposed reform on the debt — both in this decade and in subsequent decades,” said Michael Strain of the conservative American Enterprise Institute.

the prospects of fiscal conservatives derailing the legislation were reduced when Bob Corker, a leading deficit hawk, signed up to a \$1.5tn tax-cutting package over 10 years.

Under the Senate procedure that Republicans are using to advance reforms without Democratic support, they are not permitted to run extra deficits beyond that 10-year window.

That means a range of individual tax cuts are set to expire before the end of the first decade under the Senate plans — even as corporate tax cuts are kept permanent. However, Republicans are fully expecting future lawmakers to cancel those tax increases, implying lost tax revenue even deeper into the future.

Under congressional “pay-as-you-go” rules the White House’s Office of Management and Budget will be forced to offset increases in the deficit caused by the tax reductions by slashing spending by \$136bn in 2018, according to the letter from the Congressional Budget Office this week.

Among the consequences are an automatic \$25bn cut to Medicare, the health programme for the elderly. The cuts can be overturned by bipartisan legislation, however. And slashing federal spending will be formidably difficult given opposition from Democrats, who argue the Republican party is pursuing reforms that favour the rich over ordinary Americans. President Trump has said he would oppose to cuts to some of the most important entitlement programmes, including Medicare and social security.

Both bills use a similar framework, centered on corporate tax cut, from 35% to 20%, that will be permanent. But the proposed individual tax brackets are starkly different in the two plans, and cuts will expire in eight years under the Senate's bill. The plans further diverge over how to pay for the package within rules that allow for no more than \$1.5 trillion of additional deficit spending.

The Senate plan fully repeals a popular write-off — state and local tax deductions — bringing in more than \$1 trillion over the decade. The House bill kept property tax deductions, capped at \$10,000, to win over New York and New Jersey Republicans.

The GOP senators are backing a Republican House proposal to impose a 1.4 percent excise tax on investment income at private schools with endowments worth at least \$250,000 per full-time student. Analysts say the tax would affect some 60 to 70 private schools, from big names like Harvard University to lesser known liberal arts institutions like Agnes Scott College.

SENATE BILL

A report Thursday by the nonpartisan Joint Committee on Taxation said low-income earners, those making between \$10,000 and \$30,000 a year, would pay more in taxes starting in 2021 under a revised Senate Republican bill.

By 2023, people with incomes less than \$10,000 also would see tax increases.

All other income categories — including those earning more than \$1 million a year — would see tax decreases, according to the report.

ECONOMIST

SAUDI ARABIA has rounded up so many top officials that it is running out of space at the Ritz-Carlton in which to jail them. Since November 4th more than 200 princes, ministers and businessmen have been detained. A rather more quotidian Marriott has been commandeered to house the overflow. Billed as an anti-corruption sweep, the jailing also feels unmistakably like a purge of political foes. Other dramatic changes are also under way as the country pushes forwards with major economic and cultural reforms. Women will be allowed to drive from next summer. Cinemas may soon be opened for the first time in decades, as will new tourist facilities. Saudi Arabia wants to build a high-tech \$500bn economic zone on its north-west coast

The defenders of the crown prince say these abrupt changes are necessary. In an era of low oil prices, Saudi Arabia needs to diversify its economy. Decades of corruption have cost the kingdom untold billions. Unlike many of his contemporaries, Prince Muhammad is seen as hard-working and clean. But his actions so far have also been destabilising. He has shown a taste for ill-conceived foreign adventures, from a costly war in Yemen to the unsuccessful blockade of neighbouring Qatar, which has achieved little beyond dividing the Gulf Co-operation Council. Closer to home, he is ending a long period of consensual politics that ensured stability. Prince Muhammad is only 32, 49 years younger than his father. He could conceivably rule the kingdom for decades. But the list of his enemies is already long.

Increasingly, law-abiding citizens find themselves at a disadvantage in the balance of power relative to:

- Scores of well-armed government agencies with surveillance, arrest and seizure powers and significant corporate and mercenary contracting capacity;
- Criminal networks and their local gangs and snitches that enjoy the support of the politicians, black budget operatives, and banks they finance.

Gun ownership offers some protections, [providing citizens with a defense in a significant number of criminal and violent confrontations.](#)

Last week’s [intervention by a former NRA gun instructor](#) in a Texas church shooting is an important example of the role that gun owners play in protecting themselves and other people during the critical time period between the start of a crime and the arrival of law enforcement. These precious minutes often are the difference between life and death. This case also underscores why it is essential that law-abiding citizens own assault weapons.

Unfortunately, the majority of gun control proposals would strip or restrict the power of law abiding citizens, leaving them at the mercy of both criminals and a political class looking to abrogate retirement obligations and steal more assets.

As Harry Blazer says, **“What is your plan?”** Indeed, you need to have one. Assuming responsibility for your personal safety

and the safety of family and neighbors has never been more important, particularly given the mind control technologies discussed in [Control 101](#) and [The War for Your Mind](#).
