





JUSTYNA WALKER MADS PALSVIG

Our Scandinavian allies and subscribers are an intriguing group. So, it is not surprising that we love to road-trip north to Sweden. After a visit to Stockholm in April, several of us piled into our cars to return to southern Sweden for the Northern Light Convention from May 13–15 in Malmö. Although this event occurred in the 2nd Quarter, I am eager to send you this report, so I am taking the liberty of including it in the 1st Quarter 2022 Wrap Up.

The Convention was organized by Scandinavian Freedom Events, a part of the Scandinavian Freedom Foundation with sponsor support from Children's Health Defense Europe. Robert brought photographer Hans de Vries to make sure our subscribers could connect with the people who were there.

The Convention was opened with a welcome by event hosts **Justyna Walker** and **Mads Palsvig**.

Justyna is head of Notre Bon Droit Poland and founder of Verax Foundation. She is also a talented singer and artist who is one of the founders of the World Wide Demonstration movement.

Mads Palsvig is a retired investment banker who traded government bonds for thirty years for large US and European banks. He was instrumental in launching Scandanavian Freedom Events.

SUCHARIT BHAKDI

One memorable presentation at Malmö was **Professor Sucharit Bhakdi's "Pandemic Preparedness and Beyond"** regarding the dangers of mRNA vaccines—not just the Covid-19 injections, but all of the injections in the pipeline using mRNA technology.

Bhakdi is Professor Emeritus of Medical Microbiology and Immunology, Former Chair, Institute of Medical Microbiology and Hygiene, Johannes Gutenberg University of Mainz. He is the leader—and heart and soul—of Doctors for Covid Ethics (D4CE). RICHARD WERNER

Professor Richard Werner, D.Phil. presented a fascinating address, "The Case for Abundance."
Prof. Werner is a university professor in banking and finance. He holds a First Class Honours in Economics from the London School of Economics and a doctorate in Economics from the University of Oxford. He is a founding chair of Local First, a community interest company establishing non-profit community banks in the UK, and in

2008, he founded and has been director of the Centre for Banking, Finance and Sustainable Development. His book *Princes of the Yen* was a No. 1 bestseller in Japan and is one of the best sources I know for people who want to understand central banking.

Here is the description of his presentation:

"The policies pursued and recommended for developing countries by the IMF and the World Bank since their creation almost 80 years ago have not been successful. There is not a single case of a developing country that has moved decisively from developing country to developed country status. Those countries that have successfully developed did so pursuing very different policies, in contradiction to IMF/World Bank advice.

As it turns out, every country can deliver high growth, full employment, equity, stable prices and all this without crises and without major business cycles. However, presently measures are being taken by influential policy-makers to prevent the roll-out of such successful high growth policies among developing countries. What needs doing for us to move towards virtually unlimited abundance?"

CHRISTINE ANDERSON



It takes a uniquely gifted politician to lead for freedom in the current environment. That is exactly what German representative to the European Parliament **Christine Anderson** is doing. Anderson has been a Member of the European Parliament since 2019, where she serves on three Parliamentary Committees: Committee on Culture and Education; Committee on Women's Rights and Gender Equality; and the Committee of Inquiry to investigate the use of

Pegasus and equivalent surveillance spyware. She is also a member of a group of EU parliamentarians challenging the Covid-19 policies adopted by governments. In April 2022, Ms. Anderson filed a Motion for a Resolution on protecting employees from discrimination and dismissal based on their Covid-19 vaccination status. Most recently, she called Canada's Prime Minister Trudeau "a disgrace for Democracy" during his visit to the European Parliament.

In her Malmö speech, "The Dawn of a 'New Age of Enlightenment," Anderson laid out a positive vision of how we nurture democracy and human liberty.

HEIKO SCHÖNING



Heiko Schöning, MD is a research specialist who warned the public months before the Covid-19 outbreak of its pre-planning by proven criminals. He is the author of *GAME OVER: COVID-19* | *ANTHRAX-01*. He was the CEO of a clinical contract research organization, chief medical officer of a biotech company in immunology, CEO of a university center of medical technology, and a West German army officer. Up

to 2019, he worked as a medical doctor in hospitals with cancer and burn patients. Currently, he is President of WIRKRAFT.net and vice president of the World Freedom Alliance. He established the COVID-19 Extra-Parliamentary Inquiry Committee.

Following his presentation, "Exposing criminal pre-knowledge is key—Game Over: COVID-19|ANTHRAX-01," Heiko joined Dr. Meryl Nass for a discussion sharing their deep knowledge on the anthrax attacks after 9/11 and the anthrax vaccine.

Anthrax is a story that offers essential insights about current events, so we look forward to the forthcoming English translation of Heiko's book, not currently available in English.

MERYL NASS

Dr. Meryl Nass, MD, ABIM is an internist with special interests in vaccine-induced illnesses, chronic fatigue syndrome, Gulf War illness, fibromyalgia, and toxicology. As a biological warfare epidemiologist, she investigated the world's largest anthrax epizootic (outbreak) in Zimbabwe, and developed a model for analyzing epidemics to assess whether they are natural or man-made.

ASTRID STUCKELBERGER

Astrid Stuckelberger, MSc, PhD, PD, is an international health scientist with 30 years of experience conducting and directing research—from clinical to epidemiological studies and science for policy-makers (United Nations, European Commission, governments, and the private sector)—as well as teaching for 25 years at the Department of Medicine of the University of Geneva and Lausanne in Switzerland.

She has published 12 books of her own, contributed to several World Health Organization (WHO) books (on topics such as mental health policy and international research ethics training), and has written more than 180 scientific articles, policy papers, and governmental, EU, or UN reports. She received an international award from the UN Secretary General for work accomplished and from Swiss organizations; she also was nominated in the "100 personalities of Switzerland."

ALEXANDRA HENRION-CAUDE

Dr. Alexandra Henrion-Caude, PhD is a geneticist and molecular biologist. She has served as a tenured researcher at Inserm (France's National Institute of Health and Medical Research) since 1999. She earned her PhD from Harvard medical school in 1999 and received an Eisenhower Fellowship in 2013. She is the author of over 100 scientific publications and three EU/international patents.

Her vision is that our society needs a revolution in health care to develop simple solutions that are low-cost, durable, and ethical.





MARGARETA GRIESZ-BRISSON

Dr. Margareta Griesz-Brisson, MD, PhD holds degrees in medicine as well as pharmacology from the University of Freiburg/B. in Germany. She is licensed to practice medicine in Germany, Norway, Switzerland, the UK, the U.S., and Qatar. From the outset of the current crisis,


Dr. Griesz-Brisson has been calling out medical malpractice and scientific fraud in relation to face masks (especially for children) and forced injections with experimental, genetically modified substances.

PHILIPP KRUSE

Philipp Kruse is a Swiss attorney. After a career in commercial and constitutional law, he is now dedicating his life to challenging the path Switzerland is moving along with many other nations. He has led several cases in relation to regulations impacting children and constitutional controversies, and is leading several initiatives supporting activists.

Philipp spoke about the "WHO Treaty on Pandemic Preparedness—Shaping the Pandemic Creation Cycle! How do we break this cycle?" His second presentation was titled "A Report from Switzerland: Less of the same madness, BUT...."





THOMAS BINDER

Dr. Thomas Binder practices cardiology and internal medicine in Switzerland, with a thesis in immunology and virology, and 32 years of experience in diagnosis and treatment of acute respiratory illness. He was arrested and detained early in 2020 for questioning the official narrative and has remained an outspoken critic ever since.

CHRISTIAN PERRONNE

Prof. Christian Perronne is an infectious disease specialist, and a former vice president of the WHO European Technical Advisory Group of Experts on Immunisation. As chairman of the communicable diseases commission at the French High Council for Public Health, he helped several governments in the management of epidemics.

Dr. Perronne's presentation was titled, "Fake Pandemic, how to avoid the next?"



JACOB NORDANGÅRD

Dr. Jacob Nordangård is a researcher and author with a PhD in Science and Technology Studies from Linköping University in Sweden. Jacob has held positions as a senior lecturer at Linköping and Stockholm Universities and is now the president of Pharos Foundation—a think tank that highlights threats to democracy, freedom of thought, and humanity itself.

His latest book, *The Global Coup D'État*, describes how the elites of the world have used the pandemic as a pretext to reshape and digitize the world into a technocratic dictatorship. Dr. Nordangård's presentation was titled, "World Economic Forum: The Shapers of the Future."



JAMES PATRICK

James Patrick is an author, economist, and investigator from the eastern U.S. He was deeply troubled by the brutality of the lockdowns in March 2020 and the intensity of the misinformation surrounding everything Covid. In response, he set out to produce a documentary and interview series to give a voice to the unheard heroes, dignitaries, and scientists speaking out.

The resulting film, *Planet Lockdown*, was the Solari Report's Documentary of the Year for 2021.
