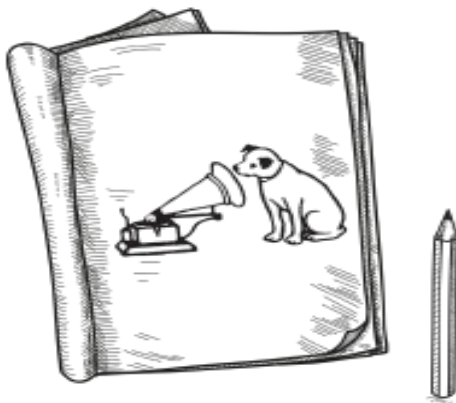

Vaxxed III: Authorized to Kill
with Dr. Brian Hooker and Polly Tommey

August 29, 2024

Transcript



Catherine Austin Fitts: Ladies and gentlemen, welcome to *The Solari Report*. I am so pleased to be talking about *Vaxxed III*, an amazing, exciting, new documentary. We are joined by Polly Tommey, the leader of CHD TV. You see us almost every week on *Financial Rebellion* with Polly. Of course, Polly, we came to fall in love with *Vaxxed I* and *Vaxxed II*, which was a life-changing experience for me. Then the unbelievable Dr. Brian Hooker, who's the chief scientist from CHD, Children's Health Defense.

Brian, if you want to get me upset, all you have to do is say, "Why is nobody doing anything?" One of the first things that happens when somebody makes the mistake of saying that in front of me is they hear a group of names pulled out to describe one person, the extraordinary amount that one person can do, and you are always one of the first examples.

Dr. Brian Hooker: Oh, my goodness, wow!

Fitts: You're two people who had a dreadful experience with vaccine injury, and now you have converted it into something that is protecting and saving millions of lives. I can't thank you enough. I told Polly at the Weston Price Conference, and Sasha Latypova and I were coming up with our heroes, and I said, "My heroes are all the vaccine-injured kids and parents who warned everyone so that when COVID came, we knew how dangerous the injections were. Of course, *Vaxxed I* and *Vaxxed II* were huge reasons that helped me tremendously.

We're here to talk about your new documentary, *Vaxxed III*. It launches in September, and we're going to hear all about it. Before we begin, Polly, why don't you give us the history because this all happened when you were censored in a film festival in New York, and you started to meet with people in the theaters where you could get a showing, and then I think it was you who said, "Let's get a bus."

Polly Tommey: Let's get a bus. I think we should go back a bit further than that if that's okay.

Fitts: Okay. You take us to where you want to start.

Tommey: I think we should send it over to Brian because if it weren't for Brian Hooker, we would have no *Vaxxed I, II, III*, and even be here right now.

Fitts: That is true.

Tommev: Why don't you tell us, Brian, how the whole thing came about and what *Vaxxed I* was about?

Hooker: *Vaxxed I* was about a whistleblower from the Centers for Disease Control; his name is Dr. William Thompson. Dr. Thompson reached out to me in November of 2013. We had crossed paths long before, but before this point, he was this brusque CDC scientist who 'blew me off'. He blew off my concerns and the concerns regarding my son's vaccine injury. When he called in 2013, he called from his private number, which was astounding.

We connected, and he started confessing that the CDC had covered up the link between the MMR vaccine and autism incidents, as well as thiomersal-containing vaccines. Thiomersal, the mercury-containing preservative used in many vaccines back when my son, Steve, and Polly's son, Billy, got vaccinated, is still in the flu shot. Dr. Thompson confessed to this fraud, and he showed me how, specifically with the MMR vaccine, if African American boys got it on time, they were three times as likely as those who merely waited until they were three years of age to get an autism diagnosis.

It was so highly statistically significant that it jumped off the page. His remorse, his story, the documents that we shared over the ten months before the whistleblower story became public in August of 2014, all of that then was documented, first of all, by Andy Wakefield and then became the movie *Vaxxed*

Fitts: *Vaxxed*: That's the first *Vaxxed*.

Tommev: That's the first *Vaxxed*.

Hooker: That was the first one.

Then that kicked everything off. Of course, if *Vaxxed I* went viral, it would be an amazing movie. I had such a wonderful time working with Polly, Del, and Andy. They captured some of my own son's story and so forth. What catapulted it was that it was banned from the Tribeca Film Festival by no other than Robert De Niro.

Reporter: "Controversy tonight over Robert De Niro's decision to pull a documentary from the Tribeca Film Festival. The documentary titled *Vaxxed* was slated to screen at the festival. The film was co-directed and written by Andrew Wakefield, who was stripped of his medical license after his studies

linking autism to childhood vaccines were discredited. De Niro pulled it from the list saying, after reviewing the film, he does not believe it contributes to or furthers the discussion he had hoped for. The movie's producer says this is not an anti-vaccination film, and it's filled with credible information that people should hear.”

Speaker 1: “Who is stopping that story? Is it a corporate interest? I don't know. Why does Tribeca suddenly not want to tell this story? I have nothing but respect for Robert De Niro and Tribeca. I can't imagine what type of pressure came down that would make them pull a movie that they were obviously behind in the beginning.”

Fitts: Tell us that story, Polly. I remember it, and I followed it in great detail. It was fascinating, and it really put the documentary on the map.

Tommeey: My part in the documentary was that we told Billy's story. I was never meant to be in the documentary; I was supposed to be a marker for someone better to be in the documentary, but they ended up keeping Billy in the documentary because the story they said was ‘bang on’ exactly what it should be for the thing. I ended up touring with Andy and Del. Before that happened, we were so excited, and then I got a call; I remember it vividly; it was on a Sunday morning, so I was about to go to church. I got a call from Del saying, “They've taken us out. We have no platform now for *Vaxxed*. It's over.”

I remember thinking, “This cannot be. All of this work. Everything that we've done.” At that moment, I didn't understand my faith or everything; I was like, “None of it makes sense.” I headed to church, did my prayers, returned, and got another phone call from Del saying, “Oh my goodness, look at the internet. It is blowing up with the hashtag *Vaxxed*.” Hashtag *Vaxxed* became huge. They realized the dark side, as I call them then. They'd made a massive mistake by putting De Niro on the television and him saying, “Listen guys, you need to see this film because he, of course, has an injured child himself.”

From then on, it backfired badly on the other side. We were getting so much traction with this film.

Fitts: Let me stop you because I don't think many people understand. You would be shown at the Tribeca Film Festival, which is run by a group of people, including De Niro.

Tommev: Yes.

Fitts: Then it got pulled, and De Niro, I think, was pretty standup. He went on TV and explained why it was pulled, but also said everybody should see it. Of course, then everybody, with the combination of De Niro saying, you should see it, and it getting pulled meant everybody had to see it.

Tommev: At that time, we didn't have censorship on Facebook, Instagram, or social media platforms. We had huge followings there doing vaccine injury stories and things like that. We were able to get out there, and everyone chatted about it. We started traveling, flying around to airports, Andy, Del, and myself, and getting stuck in airports. We were not getting the stories or getting to the places we needed to. I told Del, "Del, we've got to get a bus. We've got to be on the ground with the people not flying around spending hours."

We did. We got a tiny bus compared to the Children's Health Defense Bus. It was given to us by Dr. Sheila Ealey, whom we sadly lost recently. It was their family bus.

Fitts: Who was an amazing part of *Vaxxed II*, right?

Tommev: *Vaxxed I*.

Hooker: Of the original *Vaxxed*.

Fitts: An amazing part; an excellent, amazing doctor; an amazing woman; an amazing mother who had a vaccine-injured child.

Tommev: Absolutely, and a fantastic advocate and everything. Sheila gave us her family bus, and we wrapped it up and headed out with her with the best we could find to see what was out there on the road. I know that most people who've seen *Vaxxed II* think what we learned was incredible. I honestly went out there thinking the MMR is really bad because that hurt my son. I heard a little about a few babies dying, but I had no idea. I didn't know what Gardasil was until we got out on the road. That's how naive I was. I thought I was somewhat of an expert in MMR and autism.

The minute we hit the road, and we got our first Gardasil story, and then the dead babies kept coming in using their drugs. This was the best education that I've ever had in my entire life. We were so fortunate to have Periscope then, so

everybody lived with us. We were live all the time on the bus, and we had such a great following of people. It lifted the spirits of those who had injured children that, first of all, were not on their own.

Fitts: It was amusing when you would run these great interviews, and they are some of the best interviews I've ever seen. I keep thinking of the McDowell triplets. I love that interview. It's only 18 minutes long, but as everybody's chatting with you, and when they want to express empathy, they send the little hearts, and you show the guests the little hearts. You felt like you were a community. It was a remarkable feeling.

TommeY: We were the top Periscope group on Periscope. We had more hearts than anybody else, but the minute we made *Vaxxed II* and said, "Thank God for Periscope," Periscope was bought and taken down. That is no coincidence. We lost Periscope. It is what it is, but people talk about Colton Barrett in *Vaxxed II*. Everybody remembers Colton's story and Kari Bundy with her son, who died. It was horrific, but it was a massive education. It ended on the health of the unvaccinated, and that was important.

Fitts: What happened to you? You didn't expect this, but people started bringing unvaccinated children and telling the story, and that was a whole new, unexpected development for you. Explain exactly what happened.

TommeY: If I'm to be honest, this sounds bad. Everywhere we stopped, there would be loads of families with these unvaccinated children. I was like, "What are you doing here?" We are going around recording stories of vaccination. That sounds awful, but I didn't understand for about six months why these people were here other than to, what, show us your child is healthy. Great. We're doing people who are injured. It was that kind of attitude. It was so weird. Then bam, I went home for a break, and I was talking to Brian Burrowes on the phone, the director of *Vaxxed II* and now *Vaxxed III*, who has an unvaccinated son.

I was like, "He's telling me how his son was top of the class. It was embarrassing because every single week, he was at the top of the class—all that kind of thing. I thought, "Oh, my gosh, we've got to hear the unvaccinated stories because that's the bit that we don't know. Why have they not died of measles? Why are they there?" I suddenly realized that's why they're at every stop. We started inviting them in, which was good for our mental health because we could also do those stories. That's when it all pieced together, but I didn't

understand it for the first six months.

Fitts: You also found all these families who had started vaccinating and then ended up having older children who were vaccine injured, but then younger children who were unvaxxed. You can see the differences between the members of the same family.

Tommev: Right. That's when I called Brian Hooker, and I was like, "Listen, you're a scientist. There's something extraordinary about what we're finding," which sounds silly now because everybody knows this, but what we were finding is these two families, same genetic, same parents, same environment, same everything, have their first child injured or even dead. On the second child, they decided to space the vaccinations out because they thought maybe they just gave too many at one time. It's disastrous on that as well. Then, they would have more children without any problems. They would almost give birth in the woods, if you like, at home. "No intervention. Tell us your name."

Kendra: "My name is Kendra. This is my youngest son, Jordan. He's 17 and completely unvaccinated. I also have a 19-year-old son at home that is completely unvaccinated."

Tommev: How old did you say he was?

Kendra: "17."

Tommev: Nothing at all? No vitamin K, nothing?

Kendra: "Nothing at all. He was born at home, so there isn't even any risk of anybody slipping anything. No vitamin K, nothing."

Tommev: How come you decided not to vaccinate your kids?

Kendra: "My mom didn't vaccinate my brother, and he's about 12 years younger than me, and my dad was very pro-vax. When I got pregnant with my oldest, I knew I had to research both sides. By that point, I had worked in a DO's office temporarily, and I saw the drug reps coming in all the time. As the doctors are DOs."

Tommev: What's a DO?

Kendra: "Doctor of osteopath, MD. We had drug reps in there all the time

pushing the newest and latest drugs and that type of thing. They'd bring in food, and all the doctors would scarf down food. I just started feeling that the MD side was always pushing pharma. When I started researching vaccines, I knew one of my parents was going to be upset. Either my mom, if I vaccinated. My dad, if I didn't. I knew I needed to make a decision that was best for me. The risks of the vaccines ended up scaring me more than the risks of the diseases themselves.

I think part of it when I started was just that the vaccine was a sure risk. You are giving it to them, and then you are risking all the side effects of the diseases themselves, where you may or may not catch them. That, in and of itself, made it a little bit safer. Obviously, as I've researched more, then I know that I made the right decision.”

Tommev: When you have kids, are you going to vaccinate them?

Speaker 2: “No.”

Tommev: You know you have to pick your wife carefully. I mean it: I'm not joking.

Kendra: “We have sons. This is half to half.”

Tommev: It is a serious subject because love is love, but you've got to make sure you're on the same page with vaccines because we are seeing the most dreadful stories with people that fall out, and then the courts will rule in favor of the one that wants to vaccinate. The difference between the unvaccinated kids and the vaccinated was incredible. Brian was already doing that with his studies.

Hooker: Right. We had the good fortune of working with several different practitioners who were friendly to non-vaccinating families, and we developed a database of medical records of vaccinated versus unvaccinated children. From this, I published my first paper with Neil Miller in 2020, showing the difference between the health of the vaccinated, those following the CDC's vaccination schedule, and those unvaccinated individuals. Catherine, the difference was astounding; there were twice as many developmental delays.

In the first study, we were a little cautious. We only looked at vaccines during the first year of life, but if they got one or more vaccines during the first year, their risk of a developmental delay doubled. Their risk of asthma went up by

about 450%, and their risk of gastrointestinal disorders and ear infections also doubled. We continued to publish this, and I started to seek out more and more studies at the bequest of Bobby Kennedy, who contacted me in 2019 and said, "Let's start to feature these vaxxed versus unvaxxed studies on my Instagram and Facebook accounts." We started, and we continued to do this. I thought I'd find a few, but I found over 100 studies.

Fitts: I want to stop you because one of the things that's very shocking when you look at the history of vaccines is that all the regulatory agencies responsible for overseeing these programs don't automatically do vaxxed versus unvaxxed. In other words, it's been hard to dig up many vaxxed versus unvaxxed because, I would say, the pharmaceutical industry and the regulators have avoided doing so. Is that fair to say?

Hooker: I think they flat-out refuse to do so. In fact, that was the case when Mr. Kennedy met with Anthony Fauci and Francis Collins at the National Institutes of Health. They flat out said, "Vaccines are safe and effective. We don't have to do that study." Independent scientists have had to fill in the gaps. I was unaware of how many of these studies we would find, but it turned out that we had so many featured studies that Bobby Kennedy and I published a book in 2023 called *Vax-Unvax: Let The Science Speak*.

These are primarily independent scientists. These studies have been published and indexed in the National Library of Medicine. They're on PubMed, the vast majority of which we featured in the book. Then, there are some accidental studies where the CDC or another federal agency like the National Institutes of Health would let something slip. Usually, it was on page six of the paper, buried in some type of supplemental figure. Lo and behold, we also found evidence that the unvaccinated were much healthier.

Fitts: I have to say, I want to strongly recommend your book, *Vaxxed Versus Unvaxxed*. When it was introduced to me, it was explained. If you look at all the charts, it'll take you 15 minutes to read the book by reading the charts, and you'll get the whole story. Even if you're busy, you need to get this book because it can show you the remarkable difference and do it quickly.

Tommev: The work that went into that book as well. Brian worked hard on it. I have a couple of things I want to say about what we just discussed. Brian, another reason they're not doing the vaxxed and unvaxxed studies properly is

that it's totally unfair and unethical to do that on the unvaccinated. They would be put at great risk if they didn't have a vaccine.

Hooker: Absolutely. That was their excuse and has been an excuse from the pro-vaccine apologists talking heads like Dr. Paul Offit saying, "Oh, it'd be unethical." They talk about them dying from all of these horrific infectious diseases, and nobody's dying. In fact, it's the polar opposite: Even when you look at infectious diseases like respiratory illnesses and ear infections, the unvaccinated do better.

TommeY: One of the things we discovered on the bus was getting some unvaccinated families coming in to talk to us. Some of them had things that were not quite right with them. It is not autism, but it is not quite right, and we couldn't put our finger on it. We would return to the store and say, "Let's talk about when you were pregnant. Did you have any vaccines?" It turned out that some of these unvaccinated kids had something called vitamin K or vitamin K, depending on where you're from, at birth. I called Brian and asked, "Do your studies account for the vitamin K?" No, they didn't, did they? That was a hospital, something that was done at the hospital.

Then we looked into vitamin K, and it's as toxic as anything. It is not a vaccine, but it has all the horrible components of a vaccine.

Hooker: It has a black box warning; it has an FDA black box warning on it, but they give it to all newborns just as a standard of care.

TommeY: I remember thanking my midwife for giving my baby some vitamin K. What a nice gesture! You think to yourself, that must be something beautiful and natural. No, it's synthetic, disgusting, and dangerous. We started this big campaign on vitamin K. It was interesting because I couldn't find a doctor to speak out properly about it.

One doctor who's very well known to have said, "Look, I don't want to talk about that. If I go out saying, 'Don't get it,' which I don't think anybody should get, and something happens because sometimes things happen, then I don't want to be responsible for that."

The more people we asked, the more people were like, "Not touching it." I found this fascinating. In fact, it reminded me that we need to go back to it because the babies who didn't have vitamin K were a lot healthier than the ones

who did.

Fitts: I'm always warning people about vitamin K, and they don't know about it. Even if they know about vaccines, they don't know. *Vaxxed II* came out, and *Vaxxed I* was quite amazing. *Vaxxed II* was amazing. Then, you felt the need to go back out on a bus. Tell us what happened. How did the next bus come into being?

Tommev: We went through what we call the COVID era. We're watching television, and people- my job, before anybody says, "Why are you watching mainstream TV?" I don't, but I have to keep my eye on it because part of my job is to debunk it, if you like. I do see that. I don't watch it; I get the clicks. What we were hearing was it was a pandemic of the unvaccinated; the unvaccinated were filling up the hospitals, and they were killing everybody around, including grannies. Also, the COVID shots were safe and effective.

From the line of work that I do, and Brian does, absolutely none of that added up at all. We were trying to unravel it and decide what to do. In the end, I said, "Mary," I think I might have called you Brian even first.

Hooker: Right. You did.

Tommev: I called you and said, "We've got to get another bus. We've got to go out on the road and see for ourselves. I don't care what the mainstream says, whether it says it's a safe effect or not. It's irrelevant to me. We have to do what we did before and hear what happened from the people on the ground." The weirdest thing is that Mary said, "Yes." We have an amazing anonymous funder who helped us get that bus. We pulled our team together, and this time, I thought, "I'm going to bring young people on the team because if I can save their future baby. That's great." We brought Claire Dooley and Caroline and Tessa, three young girls.

Fitts: Claire was pregnant.

Hooker: That's correct.

Tommev: I found out she was pregnant. I was training Claire to take over for me, and she got pregnant. I saw that as a sign, "Keep going, Polls." Claire got pregnant on the bus. These young girls were on the bus, and of course, my Toby came on and did some videography as well. Young people must see what

is happening because they're going to marry somebody that person may, I've seen it before, brainwash them back to another way of thinking. These people have to be solid and firm, understanding the dangers. We alternated with these young people on the tour. What was the question? I am trying to remember.

Fitts: It was, "Tell us how you got the bus and why you got the bus."

Tommev: The lovely funder who bought us this bus and this bus was much bigger than the first bus.

Fitts: It's a beautiful bus.

Tommev: It's a beautiful bus with comfy sofas and everything else. The sides went out, but the other bus sides didn't. If you put the sides out on the other bus, it ticked.

Fitts: I have to mention you had a wonderful driver. I know that Sheila Ailey's husband drove the bus for part of the tour. He's a very magical person. It was a very magical close to the circle from the first bus.

Tommev: I called Sheila and asked, "Can Ron drive the bus?" Sheila was sick with cancer, and she said, "You know what, that is just what my husband needs right now." She said, "I have my girls around me; take him and get him out for a bit." We took Ron. It was amazing to have someone we trust. It's essential you have a driver that you trust. He was fun. He's lived through it with his children. He was hugging people outside the whole time. We had the perfect team. We loved it. Brian came on the bus.

When we set out, I thought we were going to get many COVID-shot injuries, and I heard about remdesivir, so maybe it had something to do with remdesivir, but on the whole, it probably was just COVID-19. The first stop had 25 COVID-shot injuries and deaths. I thought, "That's what we're going to get? No." From there on, after that stop, it was the hospital protocol for deaths, and they call it murder. Every single person that sat in front of me, but a few said, "My wife, my husband was murdered."

Fitts: I've been out doing *Meet and Greets* with *The Solari Report*, and that's what I'm getting; I'm getting stories of a husband or spouse who was murdered.

Tommev: Awful. Some were young as well.

Hooker: Right. The stories were excruciating, and there were so many of them of hospital protocol deaths. Also, specifically, the way that when the unvaccinated had to go into the hospital, they were treated differently; they were officially given a different standard of care because they were unvaccinated, and they were more aggressively treated with things like remdesivir, and were more aggressively treated with ventilators.

It became clear that because of this aggressive treatment really padded the hospital's numbers in terms of showing, "Oh, the unvaccinated come into the hospital, and they die of COVID." No, they died of hospital protocols. That's exactly what Polly, through these stories, was showing.

Fitts: They needed to pad the numbers; essentially, they're killing people to pad the numbers.

Tommev: When Biden was saying, "It's the pandemic of the unvaccinated, the unvaccinated are crowding and dying in the hospitals." Yes, Biden, because you killed them. That makes total sense now; you killed them.

Hooker: The protocols were so draconian, and they were also driven by Medicare and Medicaid reimbursement. This was uncanny. Listening to these stories of individuals who either went into the hospital themselves or had a loved one go into the hospital and they would test them over and over again until they got a positive COVID test. They would come in with a different, unassociated injury or unassociated illness, but they would test them, and they would retest them using faulty PCR tests until they came back positive because, you know what, COVID patients are worth more.

Fitts: Now, they kidnap them. We heard many stories of people trying to get their loved ones out of the hospital, and literally, they had been kidnapped, and you couldn't get them out.

Tommev: One of the reasons you couldn't get them out as well is that the minute that happened, they were given paralytic drugs. The minute their family members would say, "I'm getting lawyers, I'm getting everything," they were given paralytic drugs that froze these people. They tied them down in four-point restraints. They starved them, and they vented them as quickly as they could so that they could say, "Look, they're dying now." Then, when you look at the medical records, you can see Fentanyl and all the other drugs.

Hooker: Yes, Fentanyl.

Tommev: And end-of-life care. We had two 19-year-old girls with Down Syndrome killed there as well. Their parents believed that they were targeting the disabled as well. I can genuinely believe that.

Fitts: I absolutely believe that, too. After the bus trip ended, CHD published Jackie Devos's documentary about the same phenomena in the UK. It wasn't just happening in the United States; it was happening in the UK as well. You go out on the bus, and you're getting a tremendous amount of COVID injection injury and death, but now you're also seeing the unvaccinated targeted and a process of literally, I don't know how we want to describe it, euthanizing or killing healthy people, right?

Tommev: Yes.

Hooker: Right.

Tommev: How we discovered it was the unvaxxed that they were targeting; my first question would always be, "Did you take the COVID shot?" It's interesting, isn't it? Who took it, who didn't? They were like, "No, no, no." There must be someone somewhere. I called Mary and said, "Mary, they are killing the unvaccinated." In fact, I wanted to call this film *Killing the Unvaccinated*, but quite rightly, Mary said no because there are other elements of this; not only that, but it was so strong. Mary was like, "Polly, be careful. You've only been out on the road for X amount of time, and I'm not sure that's right because it's such a huge statement to make."

After eight months on the bus, we stopped because we had to get the footage out. We didn't want to keep going. We knew what this was about—it was so obvious. Having done 1,500 stories of hospital protocol deaths, you have to put them into a documentary and get them out there before it is too late.

Fitts: I remember you telling me on the Financial Rebellion; we talked before the show, and you said, "We're going to end early because we have to get this story out." I think you felt very compelled to warn people about this. "Before you go to the hospital, you have to know how dangerous it is." Right?

Tommev: Yes. Medical professionals were telling us, warning us, and you'll see it in the documentary, but then there's much more that didn't get in: this is not a

safe place. I'd ask them a question, "Would you put your loved one in a hospital?" They would say, "Absolutely not." Not after what they've seen; it is not safe. That said, in this day and age that we're in now, I'm sure it's a lot safer, but they're still doing this protocol, so you still have to take someone with you. It would be best if you never went to a hospital alone. The difference between the COVID era and now is you are allowed to take someone in with you.

Fitts: For now.

Hooker: Yes, for now. That was how they isolated these individuals. Then, all of a sudden, in the case of one of the 19-year-old girls with Down syndrome, the doctor put a do-not-resuscitate order that the family had never agreed to, and they lost that child; 19 is an adult, but it seems like a child to me now. They would be able to isolate; they would be able to threaten, be able to manipulate, and then be able to drag their way out of it.

It was just this sequence where putting a patient on remdesivir meant more Medicaid and Medicare reimbursement. Placing a patient on a mechanical ventilator means more reimbursement; putting them in the ICU means more reimbursement, death, more reimbursement, etc.

Fitts: Right. I saw a survey that said when the pandemic started, 70% of Americans trusted their doctor, and now it's down to 41%. It also seems to have made a dramatic difference, not just in trusting the medical establishment but also in trusting vaccines. Is that your experience?

Tommev: Yes, it's been this way for some time. When Billy got injured, my friend and my friend's friend saw that Billy was fine before, and they saw that he got injured after a vaccination, so they stopped vaccinating. It's the same thing here with COVID. Everyone seems to know someone who's either been hurt or injured by the vaccine or by a hospital protocol. Once you witness that, you're like, "I'm not going your way." People are not stupid. I know we still have a fair amount of people who are still brainwashed, family members of mine, even to this day. Overall, I think that reinforcements have arrived for our movement, no doubt.

Fitts: Right.

Hooker: Absolutely.

Fitts: I go back to this: Eyewitness testimony is important in a court of law. This significant amount of eyewitness testimony to me is so unbelievably compelling. That's why *Vaxxed I* and *Vaxxed II* have been so significant. We're looking forward to *Vaxxed III*. I want to point out that *Vaxxed III* has now achieved a level of censorship, which, in my experience, is unique in the history of documentaries. It's been fact-checked before the editors decided what was in it.

Tommeey: Basically, it's been fact-checked not just by any old fact-checker, but the most experienced science professionals worldwide have widely and profoundly debunked the film as misinformation, malinformation, and whatever the other information is.

Fitts: Right, but they did it before the editors decided what was in the film.

Tommeey: We still haven't released the film. It's in post-production right now.

Fitts: Now, we've entered a new era of telepathic censorship.

Tommeey: That's right. The CDC is getting their 'knickers in a twist' as well. Every time you put in *Vaxxed III*, it goes straight to the CDC. We've talked about people's tickets being declined. We're on the watch list for people to see it, and it goes on. People are having their Facebook posts taken down as soon as they say, "Hey, we're going to go and watch it," or even mention it; down it comes.

They're really, really afraid of this film. You know what, as they should be.

Hooker: Right. The subheading of the title is *Authorized to Kill*. It's very interesting because when the theaters show this on September 18th, they will not use the moniker *Vaxxed* in it. They will not say *Vaxxed III*, but it will say the subtitle *Authorized to Kill*, which, to me, *Authorized to Kill* is much worse.

Fitts: Really?

Hooker: *Vaxxed* has become such a household word that it's verboten; it's like a swear word. It should be starred out with asterisks. The movies will not show it on their Marquees.

Fitts: The marquee will say *Authorized to Kill*?

Hooker: Yes.

Tommev: You will not see *Vaxxed III* anywhere in any of those AMC theaters.

Fitts: How divinely wonderful is that?

That really expresses what you're dealing with here. I agree with you; that's much better.

Hooker: Absolutely.

Fitts: I think that there's a divine enigma here. The Marquees are going to say *Authorized to Kill*. How do we get tickets? How do we make sure we're at the premiere for *Vaxxed III*?

Tommev: If you're living in America, visit vaxxed3.org and look for your local screening. Go to that, and then see where your local theater is. Some of them have sold out. If that's the case, contact Isabella.yon@childrenshealthdefense.org, and she will do her very best to find a theater near you. We do have a big, big announcement. In fact, it will be on *Financial Rebellion* because the 18th is a Wednesday. We will have a big Children's Health Defense announcement the next morning. It happens to be *Financial Rebellion*.

Fitts: Oh, 'goody'.

Tommev: What better place to make our big announcement? We have many emails coming in from around the world asking, "How can we see it?" You can see it, but wait until the day after the theater events. Do you know what we should talk about for a moment if we have time, Catherine?

Fitts: Okay, what?

Tommev: While *Vaxxed II* was going on, Brian, Dr. Suzanne Humphries, and I went to Australia and New Zealand.

Hooker: Australia, that's correct in 2017.

Fitts: They wouldn't let you in, I thought.

Tommev: No, they let us in, but there were fewer because we didn't tell them. This is what we did: We were on Periscope, and we said, "We're not going to

tell you where we're going because if we tell you where we're going, then they're not going to let us in," which would have happened. We never told anyone we were going to Australia. I think people thought we were going to England. We went to Australia and got in super easy because they were not alert. We landed, went live, and said, "Thank you, Australia, for letting us in." They went absolutely 'crazy'.

We started traveling around, and the press was so awful. The theaters were full of--do you remember *Horrible Hank* and all those awful people?

Hooker: Oh my goodness, yes.

Tommev: Trolls, and you name it. We got through it, and Brian had to leave a little earlier. Brian left a bit early, and off he went.

Hooker: Two days early, yes.

Tommev: - Dr. Suzanne and Anu were traveling with us. I don't know if you know Anu, but he used to get stopped everywhere we went, which I thought was a bit racist, but he would always get pulled to one side. On this occasion, coming out of Australia, Suzanne was a little ahead of me, and I heard her in the security thing arguing with the security people. I shouted, "Dr. Suzanne, are you okay?" The police officer, or whatever you call these people, said, "You cannot speak to her." I said, "Oh gosh, Suzanne's been pulled aside."

A big Red Cross came up through where I went. Anu walked straight on out. It's the first country he's allowed to leave. The big Red Cross and I were detained and taken off. They took away our phones. I disappoint you, Catherine, because I would never have let them do that. They took away everything, and they told us both that we were now not allowed back into their country for three years.

To go back a bit further, an amazing organization, Meryl Dorey's organization in Australia, decided to fight the fact that we were thrown out of Australia. When they got the emails, they demanded the emails coming from the Health Secretary; in the emails, it says, "Why didn't you get Brian Hooker? How did he escape?"

They couldn't really get me because I didn't do anything wrong. They said, "Put it down as a danger to the good order of Australia." That's what I was

determined to be. Suzanne was determined to be something else, and they were furious that they didn't get Brian Hooker. I don't think for a second we will ever be allowed into Australia. I think we're done.

Fitts: Brian, you 'slipped the noose'.

Hooker: Right. I've never evaded the law without even knowing it in such a clandestine fashion, but really, wherever we went, we were embraced by the public, by individuals who have been following us through Meryl Dorey's organization, Australian Vaccination Network, yet the authorities absolutely hated us. We were condemned by one of the governors. I believe they call him the premier of one of the states of Australia by name. Just touring around the country in a little rented van, but it was quite incredible.

The level of censorship, the level of hostility from the authorities, and the level of censorship we are experiencing now with *Vaxxed III*. It seems really reminiscent of the fact that you can fact-check something that doesn't exist.

Tommev: Do you remember Matt Hancock?

Fitts: Yes.

Tommev: He said publicly that *Vaxxed II*'s makers are diabolical, dangerous individuals, and that's Toby and Brian.

It's just awful the way that they--and you know what, at this point, I think for members listening or reading this, every one of us has spoken out about our children's conditions. It doesn't matter who it is or warn people about the COVID shots. It's called a massive divide between families and friendships. I just want your listeners and readers to know that we know it's a massive divide, but we have to love them and go to their community because when you're on the chatter, either *Solari* or CHD TV, you will find your people. They are there, and you have a whole new family coming your way, but it is hard to be trolled.

Fitts: It's hard to be trolled, but the other thing is remarkable how powerful the lies are. I have to tell you a story. I think Polly's heard it, but I don't think you've heard it, Brian. They had to get the honest people out of the government during the Clinton administration because they wanted to basically engineer a financial coup, and we were in the way. We kept stopping the fraud. They had to get the clean people out, and so we were targeted and accused of all these just

unbelievable false accusations.

There was a week when we were getting a lot of accusations that we were laundering money. In my firm, I had a great chief financial officer. We had a very successful firm, but many employees were shareholders, so the financials were available to everybody monthly, and there was no secrecy surrounding the money. All the checks were signed by two people, one of which was the chief financial officer. One morning, he came to see me and said, "Can I talk to you?" In fact, his name was also Brian. We went into the boardroom, and he said, "I just have to confess this. I woke up this morning, and I said to myself, 'Maybe she is laundering money.'"

Then I realized, "Wait a minute, she can't launder the money unless I do it. I know I'm not doing it, so why would I think that you might be laundering money since I know I'm not doing it?" Here he is, and he controls the checkbook, and he's beginning to contemplate whether or not I'm laundering money and not just because the media is making things up. It was remarkable. When you get trolled like that, you have to have this amazing spiritual inner confidence that you are over the target and doing what you're doing. This is just the way it works; it's just the way it is.

Hooker: I couldn't have said it better. There's a plaque on the CHD bus that says, "Pray big." They do, and we do because if God didn't ordain this, then we would be in a 'world of hurt'. You talk about the targeting; even with the CDC whistleblower story, the trolls came after me because they said that I violated a two-party consent for recording some of my phone calls with the CDC whistleblower, Dr. William Thompson. Of course, it was absolutely not true. I traveled to Oregon, which was a one-party consent state, but what became the story for them was, "Oh, rogue university scientist breaks wiretapping laws."

Tommev: We've had our children attacked as well, Brian. Haven't we? I've had Billy attacked, and you've had yours.

Fitts: Oh, yes.

Hooker: Right. We've had our children attacked because we had the audacity. My son's a non-speaker; he doesn't speak, but we worked hard with him to gain his permission because he knew he was being filmed for the movie *Vaxxed*. He's a speller now, but he was not then. To this day, he's like, "If I could help

children and I could help people avoid what I've been through, I will do it." Yet again, anything they could attack. My son was featured with a baby bottle. Suddenly, why are you giving a 16-year-old a baby bottle? That's the only way we could get his medicine in him.

Fitts: Right. I'm looking forward to a lot of fun with both of you this fall. The movie comes out on September 18th. I think it's going to go, and it's very powerful. I've only seen the current edit, but it will be very powerful. One of the reasons it's so powerful and important is it documents beyond any shadow of a doubt there will be a victory in the court of popular opinion that the medical system and the government have conspired to murder people, and this is a crime. They have been given authority to kill, so *Authorized to Kill* is a very appropriate title.

We are talking about a mass atrocity, a crime against humanity, whether it's killing people who took the injection or killing people who got into the hospital and were targeted with these protocols, and they know what they're doing. This has ramifications well beyond the healthcare system because it has ramifications for the whole governance system and financial system. It questions the entire credibility of the system appropriately so, but obviously, many people in the system will act to defend the system.

I think part of viewing this documentary is embracing it; I always say that on the pathway to true solutions, you have to go through the doorway of grief of facing what is. I used to have a pastor who always said, "If we can face it, God can fix it." Polly's heard me say that maybe a thousand times, but we can fix it. There are real solutions here, particularly if we all know not to let ourselves get poisoned. It's amazing. Mothers of unvaxxed children tell me that they have problems with their children now in daycare centers or kindergartens because the vaccinated children don't have enough energy to play with their children. Their children have way too much energy for the unvaccinated.

It's a real problem for them, and they have to seek out unvaccinated children as playmates. We have a doorway of grief to help everybody walk through with *Vaxxed III* and come out the other side. Step one is, of course, making sure you and your family are not poisoned. I keep using the word poisoning because poison is so simple; everybody understands it. This is really what's happening; somebody's poisoning us. It's intentional, it's dangerous. We have to take charge of our health and our lives, and we need to stop it from happening whenever we

can.

I think *Vaxxed III* can help people understand the simple 411 of facing this and get back to building their lives around people and systems they can trust.

Hooker: Absolutely.

I'm going forward supporting the science because the next question is how serious is this shedding? Brian Hooker's team are working on that. Thank God, because we, in these self-spreading vaccines and all these things that were just so dark, and we really need to educate ourselves. My eyes are on the science department of Children's Health Defense and the shedding.

Hooker: We want to make sure that people get educated because you know all too well that they're trying to pull this again. They're throwing avian flu against the wall. Monkeypox, let's throw in a little Marburg and see what sticks so they can queue up the next pandemic because they're filling this \$150 billion void of all the vaccines that Moderna and Pfizer sold. Now that people have grown wise to that, they're not getting boosted, and the demand for the vaccine has gone down, but Pfizer Moderna, and their counterparts, and the other big pharma are addicted to these big profits. Yes, they are looking at monkeypox.

Fitts: We still see groups that are requiring you to get a COVID shot.

Hooker: Correct.

Fitts: There's a Rasmussen survey saying one out of four people know somebody who was killed by a COVID shot, and yet we have organizations that are still mandating and requiring a COVID shot. It's unbelievable to me that people are still recommending it.

Tommev: You have Mandy Cohen, the head of the CDC, saying, six months and up and pregnant women, get your COVID shot and get your flu shot.

Hooker: Get your flu shot.

Tommev: That's the head of the CDC.

Fitts: I hate to say it, but given what we know, that's a depopulation. In my mind, that's a depopulation program; that is what it is.

Hooker: It's challenging to go out on that limb, but the more you look at it, and the more that that message is congruent with the World Economic Forum, the World Health Organization, and then you see it happening in real-time, it's time to really go after that and call a 'spade a spade'.

Fitts: It's amusing. You don't know this story, Brian, but Dr. Skidmore and I worked for many years on the money disappearing from the federal government. He kept saying, "Why do you not give up on this story?" I said, "Mark, if we don't fix this, there's only one way they can balance the budget, and that's by lowering life expectancy, and they will do it." I told him that in 2017, '18, '19, '20. Then I said, "Okay, they will do it." Interestingly enough, 20 trillion of the missing money is missing from the Department of Defense, which ran Operation Warp Speed. I don't think that's an accident.

Children's Health Defense doesn't have to go out on a limb, but *Solari* is pleased to go out on a limb because I've been saying this. I've been saying the only way they can balance the budget at this point-- I've been saying this since 2000. I hate to say it, it's an actuarial; it's an actuarial equation.

I do want to say one thing: *Vaxxed III* was possible because we had a big donor who supported the bus. There have been many donors who supported Children's Health Defense, who've made all these great projects possible, and I have to say, I think it's a great investment. I think it was a great investment to fund that bus. I think it was a great investment to fund the scientific research that Brian and his colleagues are doing.

I want to make a pitch for funding this because I feel like when you read the Bible, you read about the walls. You can't let the walls be breached. The walls protect the town. I feel like Children's Health Defense keeps putting up the wall, and they break through the wall, and then you rebuild the wall, and they break through the wall, and when thousands of people sign the bus, you build the wall back up. We need those walls. We absolutely need science. The only way we will get good science is by funding it.

Hooker: Exactly.

Fitts: I want to thank the donors who've made this possible because *Vaxxed III* will be an incredible contribution. Every dollar counts, so sign up for those tickets. How do we sign up for the tickets again, Polly?

Tommev: Go to vaxxed3.org. Everything is on there, including who to contact if you're having trouble. If you can't see it at the theater, don't worry. Remember, tune into *Financial Rebellion* on the 19th, and we will be making a big announcement there.

Fitts: We'll let you know.

Hooker: Very exciting.

Fitts: Congratulations on this. It's going to be great. Before we close, Brian or Polly, do you want to add any last words?

Hooker: Really, this is science. People will say, "It's a collection of stories." You have such a huge collection of stories that transcends personal experience, one-in-a-million anecdotes, or whatever. You pile story upon story, and you literally hear the same thing over and over again. What the bus did is it filled the void of science. It dared do the science that the authorities would never do, and they would certainly never want you to see.

Fitts: Facts matter, and these are thousands and thousands of facts.

Tommev: I want to tell your listeners and readers we are still taking stories. We are not going to stop doing stories on CHD TV. Again, if you have been affected, especially if you're living abroad, I want to hear about what's happening in your country. Did you have the same thing going on? Then contact isabella.yon@childrenshealthdefense.org, and I will tell your story. I'll bring you on *Good Morning CHD* because we must keep doing them. Bus or no bus, we're still going to do the stories. I want to thank you, Catherine, for being such an immense support. We love *Solari* and everything you do. I know *Financial Rebellion* is our top show right now; at the moment.

Fitts: Really?

Tommev: You're right at the top.

Hooker: Yes, right at the top.

Fitts: One of my favorite poems is from Robert Penn Warren. It reminds me so much of what you both are doing with the bus. It says, "Tell me a story in this century and moment of madness. Tell me a story."

Tommev: Everyone has a story.

Fitts: Everybody has a story, and every story counts. CHD TV and Brian Hooker, Chief Scientific Officer at Children's Health Defense, thank you for joining us on the *Solari Report*. We will see you at the premier on September 18th. We cannot wait. *Vaxxed III*, ladies and gentlemen, *Authorized to Kill*. It's coming, and you don't want to miss it.

Tommev: Thank you.

Hooker: Thank you, Catherine.
